

Logical conclusion of Recognition Process

Central office congratulate all ARTEE Members for working with dedication for getting the recognition back. Every one has contributed his own way. It is the strength and display of Unit which lead to getting the Recognition back.

We the three Associations i.e. ARTEE, ADTEA and PSA have been fighting the cause in Principle Bench CAT Delhi and time to complete Recognition Process upto 30/06/2013. But beurocratic approach has been delaying the Process. Govt. took time from CAT two time s, Ultimately we filed a Contempt petition in the same court. This time court gave a time of six weeks and disposed the contempt on 6th Feb 2013.

On 16th Feb 2013 President and Gen.Secy. had a meeting with the Advocate Sh. Manish Bishnoi for changing the Advocate in EA(5K) issue in his chamber. In the Meeting Recognition issue is also discussed. Gen.Secy. ARTEE conveyed that as per his information Ministry of I & B where matter was under process can forward the matter to DOPT and than to Law for delaying. Advocate Bishnoi suggested that after expiry of six weeks time he will file another contempt for interim relief to start entertaining the Associations who has qualified for recognition.

Prior to that our unit secy of AIR Alwar and Organizing Secy. Of Rajasthan State, Sh. Ved Prakash on the request of President approached Kunwar Jitendra Singh, Minister of State of Sports and Youth Affairs and M.P. from Alwar who on our request wrote a letter on 11 Feb 2013 to Hon'ble Minister I & B to give us time for our problems. On the basis of it on 28th Feb 2013 we went to Ministry that it was confirmed that there was a communication between both Ministers and after that legal opinion was sought which was in favour of granting approval of recognition.

On 4th March again when we visited we were told that higher levels asked to putup the file. On 5th we could not go to Ministry due the funeral of our beloved great leader Sh. R.Dasgupta who expired on 4th March 2013, but we were in continuous touch with the Ministry and pursuing the case. President got the information that file is putup to Hon'ble Minister and at around 16:30 President ARTEE was informed by an officer from Ministry that Hon'ble Minister has most graciously approved the file for Recognition. President ARTEE gave this pleasant message to all CWC Members. Some of them could not believe as every body was thinking that file will be sent to DOPT/Law etc. On 6th at around 11:30 we were assured that order will be issued today. President gave this message from Ministry itself. In (AN) of 6th March 2013 order was issued. For the purpose of maintaining secrecy and for saving it from being spoiled by the forces who did not want the Recognition to be approved we kept it very confidential.

Prasar Bharati issued subsequent order on 15/03/2013 And DG AIR on 18/03/2013. All these orders are already available on our website.

On 10th March President ARTEE wrote a letter to Kunwar Sh. Jitendra Singh, Hon'ble Minister which was handed over the letter hrough Sh. Ved Prakash. It is to be noted that same Minister has helped us in stopping the EA and SEA Merger in 4200 with the designation Jr.Engr. through Sh. Ved Prakash.
