Sub: - Recognition of employees Associations in Prasar Bharati

under Recognition of Services Association Rules, 1993.

In OA No. 3591/2011 filed by some Associations of employees of Prasar Bharati, hon'ble CAT, Principal Bench, New Delhi vide its judgment dated 6.1.2012 directed the Min. of Inf. & Broadcasting and Prasar Bharati to pass appropriate orders by 30.6.2012 on the applications of the Associations for recognition under RSA Rules 1993.

In pursuance to this order, all the DDOs and PAOs were requested vide Prasar Bharati Secretariat letter of even number dt. 27.4.2012 to deduct the subscription of the willing employees in favour of the Association of their choice. They were also requested to intimate by 5th June, 2012, the list of officials alongwith the name of the Association in whose favour the employee concerned has given his consent for deduction of membership fee, so that the process of recognition can be proceeded with and the exercise completed by the due date granted by the hon'ble CAT to obviate any contempt proceedings. Vide letter dt. 16.5.2012 all the DDOs were again requested to remit to the Association concerned, the amount deducted towards subscription and to send the requisite details to Prasar Bharati Secretariat by 05.06.2012. Since the requisite information was not received from a large number of DDOs, the date was extended to 13th June, 2012 vide Prasar Bharati Secretariat letter of even number dt. 05.06.012. It was also made clear in the letter that if the requisite information was not furnished by 13th June,2012, appropriate action will be initiated against the concerned DDO/H.O.O

Again, vide letter dt. 27.6.2012, the defaulting DDOs were requested to send the compliance report to Prasar Bharati Secretariat without any further delay failing which the responsibility for delay in finalization of recognition process as per the direction of the hon'ble CAT will be on the defaulting DDOs/HOOs concerned. It was also clarified that subscription is to be deducted only in favour of the Associations who have applied for recognition (list of which was enclosed) and also to remit the deducted amount of membership fee to the respective Association and not to forward the demand draft to Prasar Bharati Secretariat.

In spite of repeated requests and warnings, some of the DDOs/HOOs(list enclosed) have still not furnished the requisite information to Prasar Bharati Secretariat. Since the last date granted by hon'ble CAT for issuing appropriate orders on the applications of the Associations for recognition is already over, the Min. of Inf. & Broadcasting and Prasar Bharati have been made liable for initiation of contempt proceedings, the responsibility for which squarely lies on the DDOs/HOOs who have still not furnished the requisite information.

This has been viewed very seriously and all such defaulting DDOs/HOOs are directed to furnish the requisite information in the prescribed proforma immediately and latest by 8th Aug. 2012.

After sending the requisite information, they should also furnish their explanation by 16.08.2012 for not furnishing the requisite information in due time thereby exposing the Min. of Inf. & Broadcasting and Prasar Bharati to contempt proceedings. The explanation should be accompanied by a certificate to the effect that the requisite information has been furnished.
