Subject : **Request for immediate action about streamlining CCS(RSA) Subscriptions.**

Respected Sir,

With regard, through this letter we want to draw your attention on following of relevant issue.

Streamlining deductions of CCS(RSA) subscriptions :

We want to bring in your kind information that as per CCS(RSA) Rules, subscription is being deducted from our Members Salary and has to be sent to Associations. The process is not being managed properly and creating excess burden of work for us as well as for offices through out the country. We raised this issue in welcome Meeting with Member(P) on 11/04/2013 and it figured in minutes also (**copy enclosed**). At present stations are deducting subscription monthly and sending us without details. As an example : If a station is having 2 of our members, Rs. 20 (@ Rs 10/- per member) are being deducted and sent to us every month and many stations are sending it without any details. We have to issue a receipt for this every month. It is a tiresome work. We suggest your good office for following measures to streamline the process :

- [1]. The RSA subscription should be deducted once in a year from the salary of our Members in the month of April every year.
- [2]. It should be sent to us with details of names, designations etc of Members.
- [3]. When ever a Member is transferred from one station to another, details about his RSA subscription should be clearly mentioned in his/her LPC with the detail of Association he/she belongs to, Upto what month his subscription is deducted etc.
- [4]. This is era of online banking all the stations should be instructed to use RTGS or other online transaction modes to deduct and deposit RSA subscription.

We sincerely hope that above said measures will streamline the deduction and it will reduce the work load in stations also. We request you to issue instructions immediately.
