Please refer to Prasar Bharati Secretariat letter of even nos. dated 26.04.2012, 27.04.2012 and 16.05.2012, 05.06.2012, 15.06.2012, 27.06.2012, 26.07.2012 and D.O. dated 21.08.2012 on the subject mentioned above.

2. In spite of issuance of the above letters, 435 out of 506 PAOs/DDOs of stations/kendras have submitted their compliance report and the same is still awaited from 70 stations/ kendras (**List enclosed**). However, it is to point out here that complete report in respect of all the 17 Associations considered for recognition has not been received from any of the DDOs/HOOs. As such, all the DDOs/HOOs are hereby directed to send the complete statement in respect of all the 17 Associations. If members of a particular Association are not available within the jurisdiction of particular DDOs/HOOs, a NIL report to that effect may also be forwarded.

3. Further, the details of in position strength of the numbers of employees within the "Distinct Category" (List Enclosed) called for vide this Secretariat letter of even no. dated 15.06.2012 from the Directorates is also still awaited.

4. I am, therefore, directed to request you to direct all concerned to furnish the requisite information as mentioned above complete in all respect **positively by 10.09.2012 to the undersigned alongwith a soft copy by email at amppc2@yahoo.co.in** failing which the concerned defaulting officers may be relieved off duties on grounds of incompetence. In case, no report is received by the above cut off date, it will be presumed that the DDOs/HOOs/Directorates have no inputs to provide and the information as available in Prasar Bharati Secretariat will be treated as final and the responsibility for any complaints/ambiguity arising out of the same will be on the concerned Director General concerned. Also, any contempt petition being filed/contempt proceeding being initiated by the Hon'ble CAT, the responsibility for the same shall squarely lies with DG, AIR/DG, Doordarshan.
