With regards Pl. take reference of letter stated above and written about Misuse of transfers by Authorities for Victimising sub ordinate Engg. Staff. **I wholeheartedly convey our gratitude for the swift action to place the impugned orders under abeyance in South Zone.**

***Most politely want to bring some complications arrived after keeping these order under abeyance.***

[1]. *In the impugned orders some Staff Members who have completed their tenure at difficult stations like Andaman & Nikobar Islands etc. were transferred. Such staff willing to join at their respective places of duties. Some of them had even booked their flight tickets which they had to cancel. They have completed their tenure at difficult stations.*

[2]. *Although there were gross violations of transfer policy but some people got their choice postings in modified orders released later and prior to kept in abeyance order issued, which are also placed under abeyance as a subsequent effect. Now these people can not join. **These people should be allowed to join either at old or new posting.***

[3]. *Some Staff Members were relieved from their stations prior to the abeyance orders to join at their new postings Now these people are relieved and can't join at new places. Their fate is hanging imbalance. **These people should also be allowed to join either at old or new posting.***

[4]. *The educational session is about to start and the staff Members have to admit their children in schools as per their places of postings. This is uncertain until they join.*

We are collecting data in cases where transfer policy is violated and very soon we will submit the same to you. Sir I request you to issue instructions to South Zone office to clear the confusion so that these deprived employee can join. An early intervention is requested from your employee pro high office.
