Minutes of the Central Council Meeting held on 18th and 19th April in DDK New Delhi

- 1 The President welcomed the house and updated on current issues. He informed that Central Office is trying its best to address core issues and he expects some positive developments soon.
- 2 AGS, on behalf of GS, addressed the house and updated on the cadre based issues.
- 3 Treasurer put up financial report before the house.

After detailed discussion following point have been resolved

- i. Prepare member wise details i.r.o their RSA subscription and maintain the data for monitoring the subscription details regularly.
- ii. Coordinate Chartered accountant for preparing balance sheet of 2013-14

- iii. Inform the post office to deliver the all letters related to the association in Room No. 542, Akashvan Bhavan / Room No. 135, DDK.
- iv. Room No. 546, Akashvani Bhavan has been renovated, so it should be locked and should be used for organizational purpose.
- 4 (a) Resignation of GS/CWC members: Detailed Part Minutes have already circulated.

(b) House resolved that Sh. Anilkumar.S (Ex.GS) should provide all documents related to cadre based issues, all Court Case files etc (Which he has kept with him as the General secretary) to Sh. Rajesh Kr. Gautum AGS for smooth functioning of the association.

- 4 (d). Anti Association Activities by some Individual Members:

House expressed their objection on defamatory allegations and postings by Sh.Chandrashekhar Shetty against the President and the Central Executive members regularly on Socializing Website like Face Book. The house opined that It is creating confusion among the members and weakening the bargaining strength of the Organization. It is also affecting the Unity and integrity of the organization, henceforth the activities are against the Association. It is resolved to keep a close watch on such activities.

- 4 (e). Joint Platform: Action will be taken as per the CWC resolution
- 5 ACP as per CAT Patna Verdict: The President informed the house that Financial Implications are being calculated for preparing a Proposal for Generalizing.
- 6 One Cadre One Pay: Financial Implications are being calculated and for this purpose data is being collected from Zones.
- 7 Tech pay Parity with Lighting Assistants: House was informed that earlier calculated implication seems to be impractical and the amount very high. It may be the reason that Department of Expenditure has rejected it earlier.
- 8 SAM Pitroda Report: Sh. A. K. Singhal briefed the house on the subject. HR content of the report is against the interest of the employees. It is resolved that resentment would be lodged against the HR content of the report
- 9 Matters related to Socializing websites: House expressed concern about showing the differences on Social Media and henceforth weakening the Unity and strength of the Organization. It is informed that CWC Lucknow has formed a committee to regulate usage of Social Media in the matters related to associations in a disciplined and positive manner. House opined that Report of the committee should be prepared quickly and it should be regulated.
- 10 7th pay commission: House discussed the issue for preparation of report on the 7th pay commission and assigned the responsibility to Sh. Anil Singhal, Secy.(AE).
- 11 Helper issue: House resolved to support the implementation of CAT Delhi verdict
- 12 UNI affiliation: It is resolved that it should be continued and fee for one year to be deposited. Information regarding newly elected body shall also be intimated to UNI/ Confederation
- 13 Cadre review: House expressed its concern about slow pace of Cadre Review Exercise for Cadres Helper to AEs. Efforts will be on to expedite the Exercise.

- 14 Rationalization of post: President informed the house about the issue and opined that it is new form of redeployment and it should be opposed.
- 15 Confusion on SMSs being sent: President informed the house that it is observed that Sh. Paritish Kaushik is sending SMSs with the names MANOJ/PK. House discussed the issue and ascertain that such messages are creating confusion among members. It is also objectionable that a Central Executive Office bearer of the level of Treasurer is sending SMSs along with a Non Office Bearer. House asked Sh. Paritish Kaushik to stop sending such messages.
