

*Minutes of Central Executive Meeting on 24/02/2014*

*Resignation of Gen.Secy.:*

*In the beginning of Meeting President requested the house that Since Gen.Secy. has leveled allegations against him, he should be allowed to submit his reply and till that Sh. Gajendra Sharma should preside over the meeting. If house finds charges of Gen.Secy. true, he is ready to quit.*

*The President submitted his reply to the house. After detailed discussions house could not find any substance in the charges leveled by Gen.Secy. and henceforth has reposed full faith in the president and asked him to chair the Meeting.*

*After discussing on the issue of resignation of Gen. Secy. Observations are given below:*

*In the beginning itself Central body expressed his desire to work Unitedly with an open heart for the welfare of Members leaving behind all the differences. Cent. Exec. has been trying to work taking Gen. Secy. into confidence, but it was unfortunate that he was trying to run the parallel show.*

*He was justifying the filing of complaints against the present body in the name of personal freedom and it is also heard that he did not present the proper side as Gen. Secy. in front of Inquiry Committee.*

*He has written letters to Authorities which has evoked controversies and created confusion among Members. Despite best of efforts he could not continue working with present body and has been adopting a non cooperative attitude.*

*He has refused to sign the bills of CWC Members even after approval of the President. In resignation, he questioned Resolutions adopted by CWC Lucknow that clearly shows that he disagree with entire CWC which represents ARTEE. It is pertinent to mention that No Individual is above Organization. Organization and welfare of the members are above our own sentiments, egos and political beliefs.*

*No body asked him to resign and he has resigned as per his own wishes. It is clear that he is finding himself unable to work with present body which he mentioned in his resignation also. Gen.Secy. submitted his resignation on 6<sup>th</sup> Feb 2014 and Central Executive has waited for three weeks time for change of his mind if any in the interest of Member's welfare and Unity.*

*Central Executive respects his sentiments and accepts his Resignation. The matter will be placed before the Central Council for further approval. Central Executive expects that he will cooperate with present body. Central body also expects that he will restrain from running the parallel show.*

*Sh. Rajesh Kr. Gautam, Addl. Gen.Secy. will look after work of Gen.Secy. and change in Authorised Signatories in banks will be done only after Approval of Central Council.*

*(2). House also discussed that post of Secy.(Helper) is lying vacant. Sh. Yogesh Kumar VP(TV) and Sh. Rajesh Kr.Gautam, Addl.G.S. proposed the name of Sh. Sant Ram (Helper) to nominate for the post.*

*House approved the nomination of Sh. Sant Ram (Helper) DDK Delhi as Secy.(Helper) in central Executive.*

*(3). EA(5K) and Once Cadre One Pay issue :*

*House was informed about latest communication between Hon'ble Ministry of I & B, Prasar Bharati and DG(AIR). House expressed satisfaction on the Progress of the issue.*

*(3). Technician vs Lighting issue Pay Parity :*

*House reviewed the current scenario of the issue. It is informed that Hon'ble Ministry of I & B has issued order to implement Notional Fixation verdict by Hon'ble Supreme Court*

*It is informed that we are collecting more information and matter of pre revised scale of Rs. 5000-8000 will be pursued with resolve. Legal opinion is also sought and issue will be pursued politically also.*

*(4). ACP PATNA : House reviewed the progress of the issue and expressed the resolve that issue require more concentrated efforts through all means.*

*(5). Cadre Review : House was informed that first meeting already held on 14/2/14. ARTEE conveyed its stand that proposal should be prepared based on three verdicts of Hon'ble Supreme Court about Tech vs LA, One Cadre One Pay and ACP as per Patna verdict. Issue will be pursued with resolve.*
