Subject : Request to implement verdict of Principle Bench Delhi in OA 1949/2012 Dated 03/04/2014 to grant ACP to Helpers in Tech Scale.

Respected Sir,

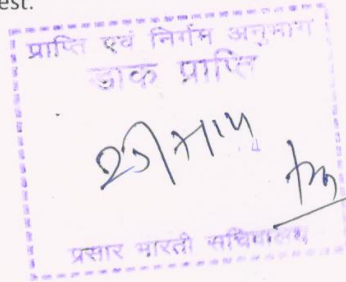
With warm regards this is to request you to implement the verdict of OA 1949/2012 dated 03/04/2014 , Rishi Raj and Others to grant ACP to Helper in scale of Technicians. The verdict was given for 45 Individuals.

On persuasion DG DD issued order no. 3/24/2012-SIV/1669 Dated 13.05.2014 (copy enclosed) and subsequently order No. C-17/14/2014-EPC Dated 21/052014 (copy enclosed) was issued by was issued by ADG(E), NZ, Jam Nagar House Delhi. On 18.06.2014 DDK Delhi has issued fixation order no. 3(10)/2012-Admn/1544 Dated 18.06.2014 for Individuals. But for utter surprise instead of implementing it, DDK Delhi has sent a query to DG AIR (Kind Attention Dr. Sanjay Dubey) and to DG DD (Sh. Jitendra Sihwag, DDA). Now the issue is entangled and shuttling between DG(AIR) and DG(DD).

It is demoralizing for employees that they are compelled to go to court of law and when they get a favorable verdict deptt. is inclined not to give them the justice. It has become a tradition that every issue is to be dragged upto the level of Supreme Court. Pl. note that our Helpers are from one of the most deprived cadre. Helpers are normally retiring as Helper even after serving the deptt. even for more than three decades.

The CAT Verdict is giving justice to grant ACP is Tech Scale as promotional cadre of Helper is Technicians and as per the CAT Verdict they have been given ACP in the Scale of Tech. after completion of 12 yrs from Date of Joining. As per ACP scheme first upgradation is given in the next promotional channel and ACP is implemented in same way in all other Govt. Deptts. The verdict of CAT Delhi provides justice to Helpers of our Department.

It will be highly un justified if the implementation is delayed. We request that the fixation order should be implemented at earliest.
