Subject : **Inviting Comments about Draft Transfer Policy as per OM Dated A-10/5/2012-PPC Dated 15.07.2014.**

Respected Sir,

With warm regards this is in reference of PB OM A-10/5/2012-PPC Dated 15.07.2014 about inviting comments on transfer policy being formulated by Prasar Bharati. (copy enclosed).

Sir the issue of transfer is very sensitive and Staff Members of Subordinate Engg. Staff from Sr.Tech to AE which are represented by this Association fall under transferrable category. As per our earlier submission dated 17.10.2013 we have reiterated that since we are Govt. Employees working in Prasar Bharati on deemed deputation, the transfer Policy which is part of service conditions should strictly adhere to DOPT Norms. As our existing transfer policy of 1981 is approved by DOPT the policy being formulated by Prasar Bharati : should be approved by PB Board and must also have DOPT Node. It shall also be better if approval of PB Board is obtained before sending it to DOPT.

After a normal look into the transfer Policy all we can say is it is a mix of good and some not so good provisions. This is a very sensitive issue which shall have immediate impact on our career, family/personal life and health etc. So we have to carefully examine all aspects of the policy and for rthis we have also invited opinion of our Members of various zones. It is very difficult to deliberate on such a big issue in such a short time which is allotted. Pl. note a complete HRD section of PB took Months and years together to formulate this.

- (1). **We request that the time limit to submit views should be extended to 31<sup>st</sup> Aug 2014. We have invited view points from our Members and we need time to compile the suggestions received.**
- (2). **We request your high office to call Meeting of all Associations to discuss such a sensitive issue.**
- (3). **We request to from a committee with representation from Associations which represents transferrable Cadres.**
- (4). **Lists of Class 'A' and Class 'C' Stations are not provided and without these lists its is not possible to have a complete look on the policy.**

We most politely request your high office to consider the request so that all issues may be addressed properly. We request to take decision on our suggestions immediately.
