

Minutes of the Central Executive Meeting held on 10/11/14 in DDK Delhi

[1]. Civil Suite CS (OS) 2684/2014 filed by Sh.Prokash Chakraborty:

House discussed the scenario, after the hearing of the case on 31/10/14. The next date is 10/02/2015. House opined unanimously that, while handling the case it should be ensured that, as far as possible, it should not reflect on the follow up of our main issue. Meanwhile,

Central Executive reiterated its earlier stand of making efforts to solve the issue amicably in the interest of Members.

[2]. Proposals on Core Issues:

The proposals have reached the Hon'ble Ministry of I & B and efforts are on that Proposals are put up as early as possible.

[A].Case for EA(5K) Generalization: As decided earlier, a case for Generalization is filed in EA(5K) issue. The order for six applicants were issued by DG(AIR) on 20.10.14. The House also regretted that the case should have been filed much earlier. But nevertheless the case is filed and shall be listed very soon.

[B]. Case for ACP Patna by ARTEE: We have already decided to file and it shall be filed with utmost cautious that it does not affect the case adversely. House discussed the issue in depth. It is informed that the proposal for OA 757/2013 is sent to Hon'ble Ministry.. As per information the similarity is established.The Proposal for Generalization is also sent to MIB. It is decided to put more pressure from the Association to Generalize it by filing an OA in the name of office bearer, who is not covered under OA 757/2013 backed by the Association.

[C]. Tech vs Lighting Assistants issue: The issue also has similar status but due to the case filed by some individuals in the proposal it is mentioned. As decided earlier a cautious decision shall be taken on the issue.

[D]. Tech (4K) issue: President informed the house that efforts are on to file contempt in Kolkata case, but we have to take caution that the mistake of EA(5K) case should not be repeated in this issue, and if required a case for Generalization should also be filed in Delhi.

[E]. Helper ACP Case: House expressed satisfaction on the positive outcome in OA filed by ARTEE and ADTEA jointly. The matter shall be raised in DG Council Meeting on 11/11/12.

[F]. EA and SEA Merger: Efforts are on that, DG (AIR) and Prasar Bharati send a proposal to merge all EAs and SEAs in Grade Pay Rs. 4600 with Designation

BroadCast Engineer and sent it to the Hon'ble Ministry of I & B through Prasar Bharati. As per information, the file is put up in DG (AIR).

[G]. MACP over and above 25/2/1999 scales: House discussed the scenario of MACP over and above the 25/2/1999 scales. House expressed satisfaction that, Prasar Bharati has taken a positive stand and sent a letter with full justification and the discriminatory order by Sh. Manoharan is also withdrawn. The House decided that if required an Agitation shall be launched on the issue.

[3]. Authorized Signatories in Banks:

Since, Sh. Anilkumar S, has refused to sign on the papers to change the signatory in Bank, it is decided that the matter shall be placed before the Central Council for further decision.

[4]. The Committee formed by CWC to Regulate the Use of Social Media by ARTEE Members in Association Matters:

The Committee has made its final recommendations. House decided to place the recommendations before the Central Council in its next meeting.

[5]. Central Council Meeting:

It is decided to hold Central Council Meeting on 11th and 12th of Dec 2014 in Delhi.

[6]. Balance Payment of Helper's Case:

House discussed the issue of 50% Payment i.e. Rs. 30,000 from ADTEA. The President informed that he has received a letter from Gen.Secy. ADTEA informing that due to some issues they are unable to make the payment and requested to cooperate. House decided to place the matter before the next Central Council.
