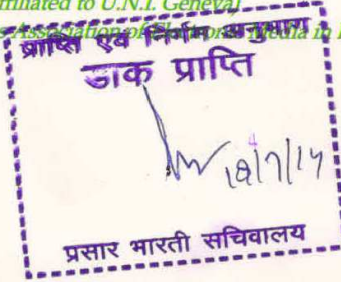

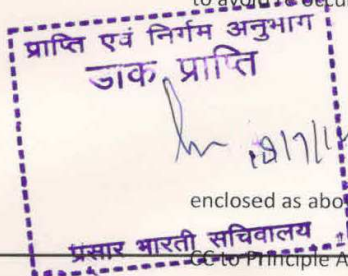
Respected Sir,

With warm regards, I want to inform you about a conspiracy to disturb Industrial peace and cordial Atmosphere between Mgmt and Associations through a derogatory and unwarranted speaking order no. 14/18/2011-S-IV(A)/291 Dated 08/07/2014. to Downgrade the Pay Scale granted Since 01-01-78 of Engg.Asstts & Sr.Engg.Asstts as per decision of Hon'ble Sup. Court which will subsequently downgrade 14000+ Employees in Multiple Cadres through Merger of EA and SEA in Grade Pay 4200. issued by DG(AIR) reference mentioned above to downgrade the Pay Scale of Engg. Asstts & Sr. Engg. Asstts granted Since 01-01-78 as per various decisions of Hon'ble Sup.Court.

While Respected CEO is making all efforts to sort out the staff matters through negotiations, the sub ordinate Engg. Cadres shocked to see such an Anti Employee Move. Most importantly the top level Management is also co operating but at lower levels like DDA and SO, there are gentle men who always think negative and always trying to create an opportunity to harm the employees without bothering that their actions will shall irrepressible damage to Cordial Atmosphere. It is surprising that these element succeeded in obtaining the approval of this order upto the level of DG Level in a very clandestine manner by concealing the facts and misinforming the Management. The culprits should be indentified and should be punished by fixing the responsibility.

The Sub Ordinate Engg Cadres and Cadres which could have been effected subsequently through out the whole country came on toes and situation became very tense. We are thankful to our Dir(A), ADG(A), E.in.C.(AIR) and DG(AIR) who took swift action and order is withdrawn on same day. But this withdrawal has caused embarrassment for the office as they have issued an order which was so negative that it has to withdraw on same day.


We think it is a very serious lapse and an impartial inquiry into the incident, should be conducted to avoid re occurrence of such incident which may lead to effect entire functioning.
