Subject : Resentment on unprecedented delay in Releasing transfer list in the Cadre of AEs in Doordarshan.

Respected Sir,

With warm regards we want to bring a very pathetic ituation in DG Doordarshan. This is perhaps the first time that no transfer list of AEs is released in DD after 28/02/2014.

It has been five months since than and staff who have completed tenures at difficults stations and waiting to come back at the time of educational sessions is suffering and bound to overstay at their respective stations. Similary staff members who had to go to replace them are also waiting. This is usal practice that lists are released keeping in view the educational sessions but even this fact has no relavance for O/o DG Doordarshan.

The staff who due to their personal genuine problems is unable to join at their place of posting in last list and waiting for consideration of their representations since thay are relived and are without salary. Perhaps this factor is also not important for DG DD. We could not find any justification for delay in this trasfer list because lists in other cadres like ADE, DDE, DDG were also stuck up but released. It is like discrimanting employees of AE cadre without no fault of their's. As per information the list is for around 40+ people (Most of them of difficult stations) which is finalized by HRD(Engg.) of DG DD and sent to DG and Admin is shuttling between sections.

We have been regulary taking up the issue and undersigned had personally talked with DG DD but list is still not released. We are surprised by this insensitive approach by O/o DG DD. Now we have come to know that now even after this long delay DG has formed a committee to discuss this list. It will delay the list further. Alreay a person who is posted at a station of one year tenure has served for one and half year. It is pertinent to mention that PB is formulating a transfer policy in which there is no provison of any such Committee.

We request your high office to take up metter with DG DD urgently for early release of list so that the diprived employees may get justice.
