Subject : Resentment for PB order no. A-10/63/2014-PPC Dated 01.4.2014 Circular No. 2/2014-PPC-I, about abolishing Vaccant posts (copy enclosed).

Respected Sir,

With warm regards we want to inform you that we have come across the above mentioned order through which all vaccant posts as on 31/03/2014 are abolished. We are unable to understand motive behind and necessasity of issuing such order.

In this reference we want to mention that, *we represent Sub ordinate Engg. cadres i.e. from Helpers to Assistant Engineers. All posts belong to these Cadres are Operational Cadres and the directive of Govt. of abolishing post paying vaccant for more than one year, is not applicable to posts of these Cadres.*

At the same time we feel that when there are Ten Recognized Associations it will be in the interests of welfare that Associations are consulted before issuing any such order. Pl. take the reference of Meeting of all Recognized Associations called by Principle Advisor and Member(F) on emergency basis on 24th March 2014 to appraise about funding problem with Govt. in Salary Head on a very short notice. All Associations attended the meeting in a short notice and expressed solidarity with Prasar Bharati in handling the situation. It would have been prudent to have discussion on this matter also.

Through this letter we convey our resentment. We expect Prasar Bharati to discuss the matter with Associations and issue detailed corregendum with number of posts in each cadre as matter is very sensitive. *We also demand that Recruitment process to fillup the vaccant posts should be initiated immediately to save these posts from abolishment in future.*

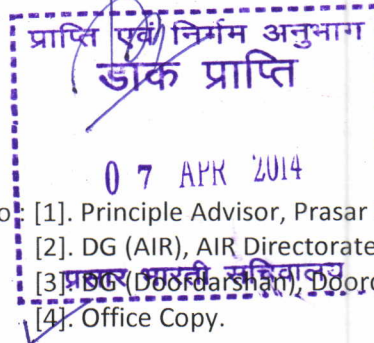
