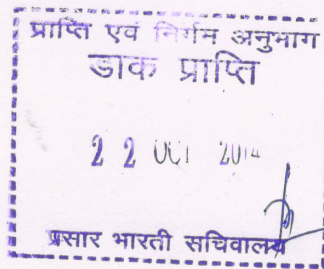
- (i) The amendment of Section 11 of the Act does not in any way affect the operation of the order dated 25.2.1999 of the Ministry.
