Subject : Inclusion of Govt. Employees working in Prasar Bharati on deemed deputation in CPC.

Respected Madam,

With warm regards, we want to bring in your kind notice that we represent more than 7000 employees working in Prasar Bharati from Sub Ordinate Engg. Cadres from Helper to Assistants Engineers. We are the largest Employee welfare Organization under Ministry of Information & Broadcasting.

Currently our status is that we are "Govt. employees working in Prasar Bharati on deemed deputation". Our status was cleared as per recommendation of Hon'ble Group of Ministers and subsequent amendment in Section 11 of Prasar Bharati Act (copy enclosed).

Madam the 7th CPC constituted by Govt. has started functioning and at the time of 6th CPC our status was cleared at the nick of the time and we could hardly get a mention in the report that we will be covered by Extant Rule. No Cadre based study was conducted for our Cadres henceforth.

The PB Act was notified in 1997 and our status was cleared in 2012. During this long period of 15 yrs. So many anomalies developed in our cadres and it has compelled employees to approach Court of law to remove these anomalies. Our Cadres are suffering from many Anomalies due to uncertainty about our status because of remaining in transit period for a long time. Since now it is clear that we are Govt. Employees this is an opportunity to settle these cadre bases anomalies through 7th CPC.

We have also written to Hon'ble Secy. Information and Broadcasting (Copy enclosed). On behalf of our Members, we request you to take necessary action and take up the matter with 7th CPC to make sure our inclusion in 7th CPC benefit shall be extended to us after a detailed study of anomalies.

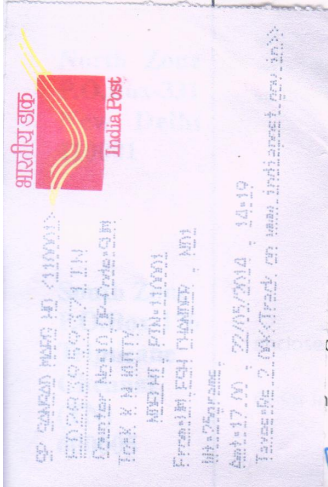
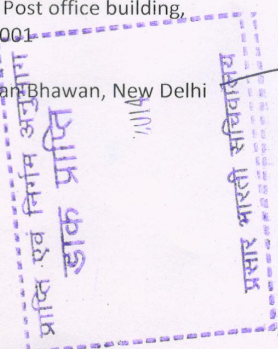
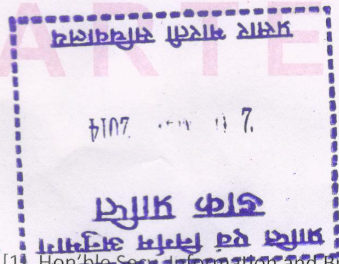
