Minutes of the Cadre Review Committee for the Subordinate Engineering Cadre held on
14.2.2014 at 3:00 pm

The first meeting of the committee constituted for Cadre Review Committee for the Subordinate Engineering Cadre was held on 14.2.2014 at 3:00 pm under the Chairmanship of E-in-C, DG:AIR, in his chamber in Akashwani Bhawan, New Delhi. The following officers along-with the representatives of the Associations were present in the meeting:-

2. At the outset the representatives of Associations raised the issues faced by the employees of the Subordinate Engineering Cadres, before the Committee constituted for the purpose. It was pointed out by the representatives that following three issues are pending for want of approval of Ministry of I&B/PB Sectt., consequent upon the judgments of Hon'ble Courts of Law.

- i) Matter of pay parity of Technician with the Lighting Assistant.
- ii) Matter of "One pay for one cadre" to the employees.
- iii) ACP to Subordinate Engineering Cadres.

3. E-in-C viewed that the issue of Cadre Review may further be discussed after the aforesaid three issues are finalized. It was, therefore, decided that the said issues may be taken up with the Ministry for early decision. The E-in-C, Chairman of the Committee desired that a D.O. letter may be sent to Member (P) at his level with request to expedite the matter with the Ministry for early decision.

4. The representatives of Subordinate Engineering Associations demanded to peruse the copy of the proposal of Cadre Restructuring of IB (E)S, which is pending in Prasar Bharati Sectt. In this connection, it was pointed out by DDA (E) that the said proposal was not processed by any of the Admn. Section, it was perhaps directly sent by EPM to PB Secretariat.

The meeting ended with the vote of thanks to the Chair.
