

Part Minutes of Central Council Meeting held in Delhi on 18th and 19th April 2014.

Agenda Point 4 (a) and (b)

Resignation of General Secretary and other Office bearers:

House discussed this sensitive issue. After detailed and threadbare discussion, the House agreed that in the interest of our Members there is no harm in talking to Sh. Anilkumar S., even though the central executive already appealed twice to all office bearers who resigned to withdraw their Resignation. Central Office also expressed its desire to work unitedly for the welfare cause. Accordingly President proposed that Sh. Deepak. S- VP (WZ), Sh. M. Seshagiri-VP (SZ) and Sh. L.R. Gupta, VP (NZ) shall talk to Sh. Anilkumar S to withdraw his resignation unconditionally and to work in the interest of the welfare of our members. House accepted the proposal of the President.

Sh. Deepak. S. VP (WZ) tried to contact Sh. Anilkumar S. But the phone was not attended, on the instruction of President, Sh.L.R.Gupta send a SMS to Sh. Anilkumar.S. After this Sh. Anilkumar.S, himself called back to Sh. Deepak S., after talking to Sh. Anil kumar S, telephonically Sh. Deepak S. informed the house that Sh. Anil Kumar S stated that he can not withdraw his resignation unless re-elections are declared.

House discussed this and resolved that, since the proposal of re-election, was placed by Sh. Anilkumar, himself in the recently concluded CWC in Lucknow and ,CWC unanimously and out rightly rejected this proposal, the Central Council is not empowered to overrule the CWC Resolution, therefore it is not possible to declare re-election. Further By-Laws amendment committee, as constituted by CWC, Lucknow, have also been started its work and shall submit their report in next CWC for the approval. Next Elections will be conducted as per the amended byelaws.

House also expressed its disappointment that even when, Central Executive has appealed twice and now Central Council also has made its efforts keeping in view of the aspirations of our Members , Sh. Anilkumar S is not ready to withdraw his Resignation leaving his reservations even for Member's welfare. House also appreciated President's efforts to resolve the crisis through negotiation even when Sh. Anilkumar S levelled many baseless charges against him in his Resignation letter.

After this house was not left with any option except accepting resignation of Anil Kumar S. unanimously and handed over the charge of General Secretary to Sh. Rajesh Kr. Gautam Addl. General Secretary as per Clause 25(vii) of the constitution.

Sh. Anilkumar S. will also be asked to handover all the relevant papers. House also expected that Sh. Anilkumar S. will co operate with the present body and will restrain from all the activities which may harm the unity and integrity of this august organization.

4 (b) Resignation of the Office bearer 2013-15 :

House discussed the Resignations of the few office bearers:

President informed the house that Central Executive has already appealed twice to the office bearers for withdrawing their resignation in the interest of unity and welfare of our members, and as on date nobody has withdrawn the resignation.

House was also informed that most of the office bearers demanding Re Election now were present in the CWC Lucknow, when Sh. Anilkumar S. Proposed for the same. All who were present have voted against the proposal.

Still in the interest of Unit and welfare, ***House Resolved to give another opportunity to the office bearers who resigned ,to withdraw their Resignations and given one week time from today i.e. 28th April 2014, after this all the resignations stands accepted and action will be initiated as per the byelaws.***

North East Zone : Since Sh. Deep Bordoloi VP(NEZ) has resigned. Central Executive has tried its best that he takes his Resignation back in the interest of the welfare of Members of North East Zone, but he does not agree. Sh. Gajendra Sharma,VP(AIR) and President himself spoke to him ample times and appealed him to withdraw Resignation in the interests of Members of North East Zone. Still house decided to wait for one week and after one week (as mentioned above) and if Sh. Bordoloi does not withdraw his Resignation, Sh. Sanjay Purkayastha, AGS-AIR(NEZ) will look after the work of VP(NEZ) as per Clause 15 (c) and 16 (v) of the constitution.

Other Zones :

After one weeks time all Resignations stands Accepted. VPs in other zones shall send the nominations for the vacant post within 15 days as per byelaws for the approval of President.

Agenda Point 4 (b)

House discussed the issue in detail. It was informed that some of our Members are trying to spread confusion and provoking Members through negative postings on socializing websites, while some Members are circulating emails with the sole intention of defaming the present leadership and central office, some of the emails are also like running parallel show. All these efforts are politically motivated and weakening the bargaining power of the organization. Some of such people have already issued warnings earlier also. In this regards following Resolution adopted:

It is resolved that any effort to spread confusion, provoking members with political motive, abusing central leadership through the Postings on Socializing websites and circulating emails to run parallel show will be treated against the interest of organization and as an Anti Association Activity. If any further violation is reported, strict disciplinary action shall be contemplated.
