

Update on One Cadre One Pay Issue

The Central office has been dedicated for Generalization of One Cadre One Pay and pursued it strategically & multidirectionally at all levels. After the Meeting with The CEO, PB dated 22/4/14 the work of preparing proposals with required Financial Implication involved there on respectively to three Core issues including One Cadre One Pay was done. Proposals sent to Prasar Bharati One after another.

After the approval by the Law Ministry in July, the process gained momentum and we uploaded a Representation on www.arteeindia.org directing all EA(5K) to submit the Representation to the MIB. We are pleased that a huge number of representations were submitted to the MIB. Many Members filed the same petition on www.pgportal.gov.in also. Along with the Central Office, the movement was led by Young Turks *Paritosh Kaushik (Treasurer), Chandra Shekhar Azad (EA), DDK Lucknow and Joseph Martin CJ, Web Administrator.*

Meanwhile, with the foresightedness of Central Office the Proposal with full Justification has been prepared and sent to Prasar Bharati. As informed earlier decisions taken by the CEO in the Meeting with ARTEE dated 22/4/14 were approved by PB Board Meeting held on 08/07/2014 and its minutes were approved in PB Board Meeting held on 18/9/14. **At this Meeting Nominated Member of Ministry of I&B Sh. J.S.Mathur was also present, so this Approval has the consent of the Ministry also.** Feeling the pressure of Representations submitted and Grievances lodged on www.pgportal.gov.in and approval by PB Board, the Hon'ble Ministry of I&B issued a letter yesterday (25-09-2014) to the CEO ,Prasar Bharati and DG(AIR) to send the Financial Implications to Generalize it. The letter starts with "I have been directed" also indicates this.
