**Additional Issues :**

**[4]. Grant of Scale of Rs. 4500-7000 for Technicians working in the pre revised scale of Rs.4000-6000 and joined between 25/2/1999 and 05/10/2007 :**

Recently deptt. has settle the issue of grant of scale of Rs. 6500-10500 to Engg. Asstt. Working in the scale of RS. 5000-8000 and order are issued accordingly. The above mentioned issue had reached finality upto the level of Apex Court.

Similarly there are Technicians who working in the pre revised scale of Rs.4000-6000 and joined between 25/2/1999 and 05/10/2007 while the incumbents having same Designation, duties and responsibilities are placed in the scale of Rs. 4500-7000.

We request to settle this anomaly and discrimination.

**[5]. Injustice being done with Sub Ordinate Engg. Employees belonging to Helper and AE Cadres in ongoing Cadre Review Exercise :**

O/o DG(AIR) and Prasar Bharati is conducting a Cadre Review Exercise to find solutions of long term anomalies and discrepancies.

This exercise is being conducted in a manner to protect interests of officers while Sub Ordinate Engg. Cadres of Helpers to AEs which are the backbone of this deptt. and largest in number are totally deprived. Our concern is not being addressed despite many reminders. The posts at higher levels are being increased to almost four times JAG and SAG Cadres at the cost of cutting the posts at lower levels.

So we request your high office to make sure that sub ordinate Engineering Cadres of Helpers to AEs being operational cadres may get much denied justice and Cadre Review Exercise may reach to its logical conclusion.


**Step 3 :** Date 16/11/2015, Peaceful Protest March, From DD Bhawan to Jantar Mantar and Gate Meeting.
