Subject : Request for issuing corrigendum to clear the confusion about DG(AIR) Order dated 23/10/15 for grant of scale Rs. 6500-10500 to EAs working in Rs. 5000-8000 scale.

Respected Sir,

With warm regards, this to express our gratitude for issuance of letter mentioned above. It is certainly a welcome step to address the 16 yrs old grievance of Engg. Asstt. Working in the scale of Rs. 5000-8000 and joined between 25/2/1999 to 05/10/2007. At the same time the order is lacking in clarity on some of the points which are mentioned below :

[1]. Unlike earlier orders issued on 14.10.14 (copy enclosed) & 17.02.15 (copy enclosed), present order has no mention that it will be effective from Date of Joining and with all consequential benefits as granted for applicants of OA 1742/2002 and 1743/2002 for M.S.Rana and Lalit Kuma & Ors. This is to pertinent to mention that present order is issued as per verdict of OA 4012/2014 filed by ARTEE for extending the benefit of OA 1742/2002 and 1743/2002 to all ARTEE Members.

[2]. The current order of DG(AIR) has a mention that it is applicable for Employees "joined Prasa Bharati on or before 05-10-2007", contrary to the Order issued by Hon'ble Ministry of I & B which clearly mentioned that it is "Applicable for Employees who are in Govt. Service". (Copy enclosed).

[3]. Since the order is for ARTEE Members, the verification of ARTEE Members may be done by Station head/DDO himself from the CCS(RSA) subscription deduction from the salary of Staff Members posted in that particular station.

In the interest of Employee welfare and smooth implementation it is must that a corrigendum is issued at the earliest which may clear confusion on the issues mentioned above. So it is requested to issue the clarification at the earliest.
