Subject : Recovery of MACP due to treating 25/2/1999 scales as an Upgradation even after absolute Stay of Hon'ble CAT in OA 2479/2015.

Respected Sir,

With warm regards, this is to inform you with disappointment that even after imposing absolute stay by Hon'ble CAT in OA 2479/2015, PAOs are Recovering huge amount of money from Retiring Employees and trying to extend the same from existing employees also.

A brief sequence of events is given below :

- [1]. Hon'ble MIB issued an order signed by Madam Harcharan Kaur to CEO, PB to comply the instructions of DOPT to treat 25/2/1999 scales as an Upgradation.
- [2]. Employees of 11 Categories agitated and PB wrote a DO letter to Re consider the decision.
- [3]. Deptt. of legal affairs advised to keep Recovery in abeyance till a final view is taken when issue was referred to DOLA. MIB and PB issued orders accordingly.
- [4]. PAO also issued order dated 13/02/2015 to keep Recovery in abeyance but still Recoveries from Retired Employees are being done every month.
- [5]. This Association filed a OA 2479/2015 to stop Recovery and Principle Bench CAT has imposed Stay on 13/7/2015, on any Recovery till next Hearing in i.e. 27/7/2015. Copy of Stay order was handed over to all Respondents. but still Recoveries from Retired Employees are being done every month which can invite contempt proceedings.
- [6]. On Next Hearing on 27/7/2015, the Stay was made Absolute. This Stay Order is also handed over to all Respondents by hand.
- [7]. Same Stay is extended in OA filed by Other Associations ADP3 2596/2015 and in another OA filed by PSA.

We request your high office in issuing orders to stop Recoveries from Retiring and serving employees by issuing clear cut instructions to all PAOs. Failing to comply the instructions of Hon'ble Court can invite contempt proceedings.
