**MINUTES OF MEETING WITH REPRESENTATIVES OF ARTEE ON
27.07.2015 IN PRASAR BHARATI:**

Shri Umesh Chandra, President, Shri Yogesh Kumar, Vice-President (TV), Shri L.R. Gupta, Vice President(North Zone) and Shri S.P. Dubey, JS(North Zone) of ARTEE met CEO at 5.30 PM. Member(Pers) and ADG(E&A) were also present. Following issues were raised:

- (i) Grant of ACP as per CAT (Patna Bench) order.

It was mentioned that on this issue, MIB have sought advice of DOPT and, therefore, further action may be feasible only after the receipt of their advice.

- (ii) Grant of MACP to categories covered under MIB order dated 25.02.1999.

Shri Umesh Chandra mentioned that while DOPT is objecting to grant of MACP to categories covered under MIB Order dated 25.02.1999, there are certain other categories not covered under MIB order dated 25.02.1999 who have been given the benefit of MACP and subsequently no recovery has been made.

It was decided to examine this aspect, based on documents / court orders to be provided by ARTEE.

- (iii) Circulation of court order on grant of Stay for recovery of MACP

Mr Umesh Chandra mentioned that inspite of stay order, recoveries are being made by many PAOs.

It was decided to circulate the Stay Order granted by Hon'ble CAT, Principal Bench, New Delhi to all the PAOs for their information.

(iv) Pay parity of Technician with the Lighting Assistants:

Shri Umesh Chandra mentioned that in a recent Court Order, Hon'ble CAT, Principal Bench, New Delhi, has not allowed payment of arrears and as such the expenses would now be approx. Rs. 6.00 Crore per annum.

CEO desired that this may be looked into as per Rules.

(v) **Transfer Policy**

Shri Umesh Chandra suggested that, in the transfer policy the powers for transfer of employees within the zone be vested with the Zonal Heads and not DGs.

It was decided to look into this matter.
