ORDER

In pursuance of the order of the Hon'ble CAT Patna, as modified by the Hon'ble High Court, Patna in OA No. 514/2002, the Ministry of I&B had constituted a screening Committee under the Chairmanship of Joint Secretary (Broadcasting), Ministry of I&B to consider the eligibility of the applicants of the said OA for their ACP benefits. The Committee in its meeting held on 2/1/2012 and 3/1/2012 had found that Sh. Harendra Kumar Mishra, Sh. Sudhanshu Kumar and Sh. Manoranjan Kumar, Senior Engineering Assistants and 5 others are eligibile for benefits of the ACP Scheme w.e.f. 01/01/2008. This approval was conveyed to this Directorate by the Ministry and necessary orders granting benefits of 1st ACP were issued vide order No. 8/3/2011-S.IV(B)Pt.II/34 dated 17/01/2012

- 2. Sh. Harendra Kumar Mishra, Sh. Sudhanshu Kumar and Sh. Manoranjan Kumar had subsequently filed another OA No. 350/2013 before Hon'ble CAT, Patna praying 1st ACP may be granted to them in accordance with the ACP Scheme of DoP&T and in terms of the relief granted to Sh. B.K. Roy, Sr. E.A. The Hon'ble CAT has ordered that the benefits may be granted to the applicants as prayed in the said OA No. 350/2013.
- 3. The Ministry of I&B, vide their communication No. 515/18/2013-BA(E) dated 21/1/2015 has authorized this Directorate to constitute Screening Committee in the Directorate itself and to grant benefits of ACP schemes to its Group B employees as per para 6(2) of DoP&T OM No. 35034/3/2008-Estt (D) Vol.II dated 10/12/2014. Accordingly, considering the orders of the Hon'ble Courts in OA No. 514/2002 and OA No. 350/2013 and in accordance with the ACP Scheme 1999, it has been decided to revise the dates granting 1st ACP in respect of the following officers as under:
