ORDER

Whereas, in O.A. No. 171/2006 filed by Shri Vimal Kumar Sharma & another Vs Union of India & ors, Hon'ble CAT, Jabalpur in their order dated 25.11.2008 directed the respondents to grant the pay scale of Rs.6500-10,500/- notionally with effect from the date of appointment and actual with effect from 1st April,2006.

- 2. Whereas, consequent upon the judgement in Writ Petition No. 1867/2009 arising out of the aforesaid OA No. 171/2006 the Hon'ble High Court of Madhya Pradesh in their judgement dated 18.08.2010 has inter-alia stated that the petitioners are entitled arrears of salary from the period before three years from the date of filing of the application before the Tribunal. The application was filed by the petitioners before the Tribunal on the 20th March, 2006, hence the petitioners are entitled the arrears for salary from 20th March, 2003 and accordingly, the order dated 25th November, 2008 passed by the Tribunal in OA No. 171/2006 is modified.
- 3. And whereas, in the O.A. No. 1176/2010 filed by Sh. P.K. Maheshwari & another and OA No.3885/2010 filed by Shri Rakesh Kumar & 5 Ors., Hon'ble CAT, New Delhi in their judgements dated 25.01.2011 and 18.05.2011 respectively directed the respondents inter-alia to verify the submission of the applicants, and in the event of the applicants being found similarly placed as Shri Lalit Kumar Pawar and others, same benefits be extended to them.
- 4. Whereas the above mentioned orders of the Hon'ble Court of Law were referred to Ministry of I&B for advice/suitable decision. Ministry of I&B in turn vide their letter No. 515/50/2011-BA(E) dated 30.01.2015 have conveyed the approval of Ministry of Finance for implementation of the order of Hon'ble Court of Law to the applicants only.
- 5. Whereas, in view of the directions of Hon'ble Court of Law and approval conveyed by the Ministry of I&B, the pay scale of Rs. 6500-10500/- is granted to the applicants of the aforesaid OAs only as under:-
- a) Notionally with effect from the date of appointment to the post of Engineering Assistant and actually with effect from 20th March, 2003 in respect of Sh. Vimal Kumar Sharma & another only.

- b) From the date of the appointment to the post of Engineering Assistant or after 25.02.1999 whichever is later in respect of the applicants of the OA No. 1176/2010 and OA No. 3885/2011 only.
- 6. This approval is in respect of the (10) Ten applicants only of the aforesaid OAs in the light of approval conveyed by Ministry of I &B dated 30.01.2015.
- 7. This issues with the approval of the competent authority.
