OFFICE ORDER No. 141 / 2015-PPC

With the approval of the Chief Executive Officer, Prasar Bharati, it has been decided that henceforth, the Competent Authority to consider proposals of transfer/posting of officers as well as shifting of posts in Prasar Bharati (All India Radio and Doordarshan) will be as under:-

2.	All transfers / postings of officers, including shifting of posts, of Group 'A' below SAG level in all cadres viz. Programme, Engineering, Administrative, etc.	Member (Personnel) - on the recommendations of a Committee chaired by concerned DG and comprising of (i) ADG(Ops), PBS (ii) ADG (A), DG:DDn, (iii) DDG(A), DG:AIR and (iv) concerned E-in-C (in case of Engineering Cadre).
3.	All inter-zonal and intra-zonal transfers / postings including shifting of posts, of officers of Group 'B' (Gazetted and Non-Gazetted), Group 'C' and Erstwhile Group 'D' in all cadres viz. Programme, Engineering, Admn., etc	Respective DGs - on the recommendations of a Committee comprising of (i) ADG(A) / DDG(A) as Chairperson, (ii) Director (A) and (iii) DDG(P).
4.	All inter-directorate transfers / postings of officers of Group 'B' (Gazetted and Non-Gazetted), Group 'C' and Erstwhile Group 'D' in all cadres viz. Programme, Engineering, Administrative, etc.	(i) ADG (Establishment), PBS for Group 'B' officials - on recommendations of a Committee comprising of (a) DDG/Director (Estt.), PBS as Chairperson, (b) DDG (A)/Director (A), DG:AIR, (c) DDG(A)/ Director (A), DG:Doordarshan and (d) DDG(E) / Director (E) in case of subordinate Engineering Cadre.

		(ii) DDG/Director (Estt.), PBS for Group 'C' and erstwhile Group 'D' officials - on recommendations of a Committee comprising of (a) DD(A) (Estt.), PBS as Chairperson, (b) DD(A), DG:AIR and (b) DD(A), DG:DDn.
5.	All transfers / postings to and from Commercial & Revenue Divisions of Prasar Bharati	Member (P) on recommendations of a Committee comprising of (i) ADG in Prasar Bharati Secretariat looking after CRD as Chairperson, (ii) ADG(A), DG:DDn and (iii) DDG(A), DG:AIR.
