Update of Issues as on 24.09.15

[1]. ACP PATNA:

Implementation is progressing satisfactorily. Some significant development expected up to 14' Oct 2015. All members are cautioned not to spread any negative information. We have to be cautious from internal and external enemies of ACP. Central Office want that output should be achieved as early as possible.

[2]. Generalization of One Cadre One Pay for EAs (5000-8000):

As informed earlier, file was sent to Department Of Expenditure on 18th Sep 2015. All efforts are being made to follow up the issue in Department Of Expenditure.

[3]. Tech vs LA Pay Parity in 5000-8000 Scales w.e.f. 01.01.1996:

After the recommendation of Department Of legal Affairs for generalizing it for all Members of ARTEE as per OA 4424/2014 filed by ARTEE and Sh. Deepak S. (as an effected party), Hon'ble Ministry of I & B is likely to prepare a proposal and send it to Department Of Expenditure in the line of EA(5K) issue. Efforts are on to send the proposal as early as possible.

All Tech and Sr.Tech Members are cautioned to be aware of efforts from a handful of leaders who are trying to confuse Members. This issue is equally important for us and it is only due to our efforts that Department Of Legal Affairs has recommended the scale for all ARTEE Members as per OA 4424/2014, even when the file was sent to obtain opinion in an Individual Case.

[4]. Generalization of Helper ACP in extending benefit of OA 1949/2012:

As per information Government has filed a Writ Petition in Hon'ble High Court Delhi which is going to be listed on 28.10.2015. ARTEE's OA 3607/2014 is likely to reach its logical conclusion as per the outcome of this Writ Petition.

[5]. Tech (4K) Issue:

ARTEE regret that the delay in filing the case which should have been filed way back. In the Case OA 1575/2015 filed by ARTEE, Government has not yet filed any reply. The issue came up for listing on 17.092015. Since Government has not filed any reply the next date is fixed, as 18.11.2015. Meanwhile the verdict in a case filed in Individual capacity is awaited.

[6]. MACP Recovery due to 25/2/1999 scales as an Upgradation:

The OA 2479/2015 was listed on 24.09.15. It is clubbed with case filed by PSA in the same matter. Government has not filed any reply in this case also and the next date of hearing is 02.11.2015. Meanwhile contempt petition is being filed to stop recovery.

[7]. Recovery of 3rd MACP from Sr.Tech:

The OA 3035/2015 is being listed on 28.09.15. After the stay on Recovery, Authorities have stopped the Recovery from our members.

[8]. Cadre Review:

A meeting under the chairmanship of Member (P) held on 14.09.15 and ARTEE raised its concerns on this matter. Member (P) asked to submit a representation.

ARTEE Central Office wants to caution Members not to fall in the trap of ill intended propaganda with the malafide intentions to fulfill vested interests of a segment. It is pertinent to mention that when something goes wrong on our long pending demands, some elements always stat propaganda that Central Office is responsible for that.
