

1. The representations of the AEs received till 12-01-2016 have been considered by Transfer Committee.
2. The concern Head of Offices / ADG (E) Zone, TVM has to ensure that **AEs of one year/ Two year difficult stations under their control, should be relieved only after completion of tenure.** AEs of Stations other than tenured difficult stations, stands relieved within ten days of issue of transfer order.
3. Once the transfer representation against a particular order has been considered and a decision has been communicated, no further representation against the same order shall be considered by this Directorate at least up to 6 months from the date of the decision communicated.
4. Request for transfers received to the Directorate shall be considered by the Transfer Committee in its meeting and orders shall be issued in respect of those where it is decided to accept the requests. Once a transfer order in a particular Cadre has been issued after receipt of the representations or requests of transfer in that Cadre and the name of a person does not figure in that order, it may be presumed that the request has been rejected by the transfer committee.
5. A Compliance report is to be sent to this Directorate immediately.
6. This issues with the approval of Competent Authority.
