All ARTEE members are hereby informed that Bank Accounts of our Association is freezed due to the complaint by Sh. Paritosh Kaushik, (Ex Treasurer) to Bank Authorities. It is also informed that Sh. Paritosh Kaushik is suspended from the post of Treasurer. We regret that this was not a pleasant decision, but it has become our compulsion, because since last many months we are running our Association from the donations collected from Members and from office bearers.

The adamant attitude of Sh. Paritosh Kaushik that he will not release funds for welfare activities after October 2015 has made the work further complicated. We have been pursuing him to release funds just after the expiry of Association Registration to renew it. Initially his stand was that he will release funds only for Election and for Organizing National Convention Allahabad which was being organized on the directions of Hon'ble High Court Delhi. Later he refused even for this and as on today the balance expenditure of the National Convention is still to be cleared.

Now, we are trying our best to handle the situation in Bank. It may take some time for things to be settled in our favor. But many welfare oriented urgent works are suffering due to shortage of funds and some of them are related to the existence of this august Association.

Some of them are listed below:

[1]. Funds for Renewal of Registration of ARTEE in Allahabad. (**Top most priority**)

[2]. Funds for Challenging the ACP PATNA in ARTEE Case OA 4249/2014 in High Court Delhi or to file fresh OA in CAT Delhi. (**Most urgent**)

[3]. Renewal Charges of ARTEE website <u>www.arteeindia.org</u>. These Charges are due from October 2015 and Treasurer was informed well in advance to release the funds. (Now this amount is paid by President).

[4]. Afflation fee for Bhartiya Mazdoor Sangh for the year 2015-16.

[5]. Affiliation fee for Union Network International, Geneva, for year 2014-15 as the cheque is returned due to time bar) for and 2016-17.

[6]. Funds for Clearing TA/DA bill of delegates attended National Convention, Allahabad and balance expenditure in Allahabad which was conducted as per the directions of Hon'ble High Court.

The Registration was expired in October 2015 and when went to renew, we came to know that **Sh. Prokash Chakraborty has filed a complaint in O/o of Assistant Registrar of Societies Allahabad** and it had made renewal difficult. Until his complaint is settled Renewal is not possible.
