

## **? ?Why ARTEE is not constituent of NFADE ??**

A letter signed by office bearers is published on social media. People are questioning about my signatures on the paper.

My first question to them please disclose how they got this letter. ???

This is another proof that these people are not trustworthy at all and are masters of misrepresenting the facts. They have become habitual of betrayal. This is the biggest obstacle is creating an Atmosphere of faith.

Anyway on 21/9/16, when it was sensed that DG(AIR) is on the way to victimize some Individuals, without any consultation with us ADTEA President called a meeting of all Associations.

The hidden Agenda was same as it was on 8/9/16 when the Agitation was launched which has resulted today's situation. The Agenda was to revive federation under the leadership of Sh. Anilkumar S. & Sh. Bhatia.

Same day we had called our meeting of Central Executive to discuss the issue of Participation in NFADE and I was About to leave to go to attend our meeting when Sh. P.K.Kohli, Gen.Secy. ADTEA came to my room and requested for half an hour as I was not agree to participate NFADE meeting before we decide whether to participate in it or not.

So I was ready but he kept on insisting on the issue of victimization. Then I agree to attend the meeting conditionally subjected to confirm our participation in NFADE after the decision of Central Executive. I attended the meeting as President of ARTEE and not as constituent of NFADE.

Here I want to mention that in last three yrs. we have tried to revive NFADE five times but each time some people who are now behaving like biggest supporters of NFADE spoiled those meeting. Perhaps they were taking feedbacks from some hidden corners. One of them is Sh.V.N.Jha who is now supporting. In those meetings he put his best efforts that NFADE is not formed.

There was one meeting in Aug' 2013 on Sh.O.K.Sharma ji and my initiation in Mandi House. In this even ADASA was agree but Shri Kohli asked that ARTEE and ADEA (Officers Association) should apologize. The meeting was unsuccessful due to this. These people backed by some great minds did not wanted that Federation is revived without them.

Even on the common issues of 7th CPC and funding after March 2017 there refused to come forward. Now since these people are in trouble now they want to revive NFADE under their own leadership. \*So for non revival of NFADE they themselves are responsible.\*

Any way in that meeting all Associations were present and all were against victimization.

Some Associations like ADEA were there but refused the signed this letter. On behalf of ARTEE I clearly said that my signatures are conditional and it is subjected to the decision of our Central Executive. But still they deliberately

wrote my name as if I proposed. They insisted like anything and when I checked it, I struck the portion where my name is mentioned.

It was not decided to write any letter to Authorities but betraying our faith and trust on the same day a letter is written signed by by Sh. Kohli and Sh. N.K.Gemini. This was second betrayal of faith.

Next day in the meeting of Central Executive it was decided not to join NFADE and in the meeting itself we came to know about the letter written to Authorities. On this issue another Recognized Association ADSA (Stenographers Association) left NFADE. Not only they wrote letters but with out knowledge they started getting meetings on behalf of ARTEE without even telling us.

After issuance of Chargesheets again a meeting was called on 19th Oct 2016 and Sh. R.Srinivasan requested me to come. Pl. note they want ARTEE support but ARTEE was being treated very shabbily, even the invitation to ARTEE was not extended. We are being insulted by some ARTEE people who have been working for ADTEA since last three years. They are become ADTEA consultants.

So Mr. Srinivasan requested me to forget everything and to be united against victimization. Due to my personal reasons I could not attend the meeting but I conveyed my concern that even without joining NFADE with are against any Victimization. After the meeting Sh. Srinivasan (Just note that not any one from those who want us to join NFADE) informed me that he conveyed my message and it is decided that A letter will be drafted and will be sent to all Associations. ARTEE never got this letter. Just see in a very mischievous manner they called Sh. Rajesh Kr. Gautam and got Agitation letter signed. We agreed with Gautam and asked him to talk to Sh. Anil to send a SMS that he is with present body. Even I sent some SMS but of no use. So they betrayed Gautam also. (Details of this are already given on website).

On 18/10/2016 Sh. Shyamveer Singh , ADTEA President called me and threatened me to demand inquiry against me for my Kargil stay. Just think the situation ADTEA President threatening ARTEE President to demand an inquiry. What a mockery of Unity. I challenged Sh. Shyamveer to go ahead. Again I challenge every one who is willing to go ahead. They want ARTEE in NFADE and keep on insulting us. (If Sh. Shyamveer denies I am ready to give evidences)

On 07/11/2016 Some people came to meet us in Delhi. However some of them shouted on us and insulted the leadership in abusive language but still for the sake of protection against Victimization we assured to review our stand on NFADE but just when discussion was going on, on Social Media again the abusive things were posted. We were called Chickens and some great people were shown as Lions.

**Both our Participation and Insult, threatening and disowning of ARTEE can not run together.**

Just see the situation of this NFADE as on today :

- [1]. ARTEE is not part of it.
- [2]. ADEA (Engrs. Association) is not part of it.
- [3]. ADSA (Stenographers) is not part of it.
- [4]. ADP3 is not part of it.
- [5]. CCW Employee Union is not Recognized.
- [6]. ADASA is not part of it. (As per Sh. R.S.Chauhan, Gen.Secy. ADASA, their office bearers Sh. Sommiah and Sh. Raj beer Sing Mann who are participating in Agitation have submitted their Resignations and these are accepted.)
- [7]. Anyone can adjudge the strength and power of other Constituents.

Now please note the following :

[1]. Why these people purposefully destroyed the move to revive NFADE in last three years five times ?

[2]. Why they refused revival of NFADE even for common issued like 7<sup>th</sup> CPC and Funding ?

[3]. When ARTEE gave its consent to join NFADE ?

[4]. Why ADTEA President threatened ARTEE President ?

[5]. Why the Agitation programme was prepared without any consultation and preparation with ARTEE ?

[6]. How it is possible that they keep on insulting ARTEE and we keep on supporting them.

[7]. Why they circulated this letter which is signed with all good intentions and how it can be treated our consent for joining NFADE ? Is it not betrayal of faith ?

[8]. How ARTEE may be a constituent of a platform when another constituent ADTEA President has threatened ARTEE President ?

Our concern for victimization is unquestionable but we don't need lessons from people who don't know facts and who are always working to weaken ARTEE in last three years.

Last but not the least that the person who is most needed ARTEE support should atleast accept and acknowledge present leadership which he has disowned.
