On behalf of this **Association which is the largest in the deptt.** and Nationally **Affiliated to Bhartiye Majdoor Sangh** (the largest CTUO of the country), we wish to inform you following :

[1]. As per the unanimous Resolution adopted by Central Executive dated 27/10/16 of this Association ***we want to inform you that this Association has reviewed it decision conveyed to you through letter dated 24/10/2016 and we have decided to extend our Moral Support to the Agitation as we are against any Victimization.***

We will review the situation time to time and it will be informed to management in due course. However we convey our concern to the issues and wish that it should be resolved as early as possible. We also wish to maintain Industrial peace and willing to solve the issue through dialogue as Agitation is the last resort.

At the same time we want to stress the need of an effective redressal mechanism as per JCM norms with representatives of employees.
