

# **Minutes of Central Executive Meeting dated** **26.04.2016**

A Meeting of Central Executive was organized in Room No. 134, Akashwani Bhawan on 26.04.2016. Following Office bearers were present.

Details of discussions are given below:

## **[1]. Civil Suits against Association in Patiala House Delhi:**

House discussed the issue. The order of hearing dated 08.04.16 is available now. It is clear. Hon'ble Court has issued Notice to Respondent no. 3 and 4. It is decided to obtain advise of our Advocate with undertakings by plaintiffs of both the suits and proceed further accordingly.

## **[2]. Recent Resolutions of by P&D and NBH Units:**

House adjudged that the pressure being mounted by these two Units is illegal and the Resolutions adopted are against the byelaws. In our byelaws there is no such provision. It is also against the Unity/Solidarity of the Association and henceforth it is an Anti Association Activity. House expressed its displeasure that on one side these units want the present body to declare fresh election and the same time disowning it.

***House resolved that if any of Unit informs Authorities about these Resolutions and if it causes any harm from management, Central Executive will consider taking action against Unit Secretaries and recommending dissolution/suspension of these Units to CWC as per clause 29.***

House also condemned the act of pressurizing the President illegally to declare fresh elections. The House also sensed that there may be a nexus among such people as the Resolutions and pictures of discussion by Members of these Units with President are uploaded by an individual from Karnataka, who has been expelled due to his continuous Anti Association Activities.

House also decided to issue an Appeal to Members to strengthen Unit and not to fall in such propaganda with malafied intentions and to seek VPs opinion on this sensitive issue.

**[3]. Abuse and Anti Association discussions on Social Media:**

The House expressed concern on continuous abuse and use of un Parliamentary language by few Individuals. Even though, we always promote use of social media for positive purposes but such misuse can not be allowed.

House Resolved to issue show cause notices to such frequent offenders and to initiate disciplinary action against such individuals as per bye laws.

**[4]. Recovery of MACP due to 25.02.1999 Scales:**

The House reviewed the scenario. It is really painful that despite Stay by CAT Delhi recovery is being done continuously. This month also recovery from two AEs is reported. President informed that matter is pursued at all levels. The House resolved to deal the issue with top most priority and sense of urgency. If required a fresh round of Agitation may be launched.

**[5]. ACP PATNA and ongoing hearing of MJC 2918/2015 by Sh.N.K.Srivastava and ors.**

The House discussed the progress of hearing in MJC 2912/2015 by Sh. N.K.Srivastava and ors in Hon'ble High Court Patna as this case has become very vital for the future of the issue. President informed that he had talks with Applicants and offered them all kinds of support.

**[6]. Tech(4k) and Tech Parity with Lighting Assistant issues :**

House expressed satisfaction on the progress of both the issues and decided to monitor it with sense of urgency.

Meeting ended with a vote of thanks to the chair.
