Brief of issues discussed:

- [1]. **Issue of withdrawal of One increment granted at the time of Fixation of Pay in 4th Pay Commission and withdrawal of benefit of FR-22 on promotion from EA to SEA:**

Association presented this issue with all supportive documents and reiterated that this issue has not been raised anywhere except DG Doordarshan.

Proposal to be immediately examined to stop the practice of recovery at the time of retirement.

Action by S.IV Section.

- [2]. **Accounting and fixation procedure for finalizing terminal benefits :**

Association pointed out that one year before retirement, the service books were not being sent to Inspection Unit for clearing terminal benefits of retiring employees. The change of system has brought in many complications and it is delaying the payment of retiring benefits.

Association also brought to the notice of the Chair the growing resentment among employees in delaying the clearance of retiring benefits while as per rules the process of clearing retiring benefits should be started 8 months prior to retirement.

Matter has been taken up with PB. The process should be taken up atleast 10 months prior to retirement.

Action by S.II Section.

J. Payment of Tribal Allowance :

Association pointed out that as per order of DoEXP 17(I)/2008 E II(B) dated 29/8/2008 Tribal Allowance Rs. 400 per month for GP 5400 and above and Rs. 240 per month for GP below 5400 has to be paid. But this is not being paid uniformly. Representatives requested to issue orders to pay it in all eligible DD Establishments.

Necessary Order to be issued immediately.

Action by Scor Section.

[4]. GPF Related Problems :

Association pointed out that in AIR, GPF Number remains unchanged under one PAO but in DD, even in same building, if Office changes, the GPF Account Number is being changed. This and other related problems should be solved.

To be immediately addressed.

Action by Cash Section.

[5]. Delay in grant of 5400 Grade Pay to AEs on completion of 4 yrs :

Association presented the issue that despite all appropriate orders, Applicants of 5 OAs are not being granted this benefit as per Recommendations of 6th CPC. Contempt are also pending in CAT Delhi.

To examine the verdict and take immediate action.

Action by S.IV and other Staff Sections.

[6]. Non disbursement of Consequential benefits to EAs working in 5000-8000 Scale who joined between 25/2/1999 to 05/10/2007.

Association has brought to the notice of the Chair that in OA 4012/2014 filed by this Association for its Members the order for grant of scale of Rs. 6500-10500 to 434 EAs of this Association was issued by DG(AIR) in concurrence of all Nodal Ministries like DoLA, DoPT and DoEXP.

The fixation is done after the issuance of Orders by DG(AIR) but the consequential benefits like Arrears are not being paid. A contempt No. 227/2015 is also pending in CAT Delhi and due to this delay, Hon'ble Court is refusing to dispose the contempt.
