# <u>Details of Discussion in the Meeting of Joint Establishment</u> Council under the Chairmanship of C.E.O Prasar Bharati.

The meeting of Joint Establishment Council of Prasar Bharati held in Prasar Bharati Secretariat. Member (P), Member (F), DG (AIR), DG (DD) and other officials were present in the meeting.

ARTEE had submitted its agenda in July 2015, we had several other points also.

Our other Core issues which are already pending in Hon'ble Ministry of I & B were not included in the Agenda since Prasar Bharati has already taken a decision on those issues. So only the leftover issues were discussed in today's Meeting.

[1]. Tech (4k) issue: Grant of Pre- revised Pay Scale of Rs. 4500-7000 to Technicians joined between 25.02.1999 to 05.10.2007.

Prasar Bharati informed we have written Ministry of I&B about this. President informed the Management that on the hearing of OA 1575/2015, filed by ARTEE on 25.02.2016 Hon'ble MIB has submitted in CAT Delhi that they are willing to implement this and sought a time of 12 weeks.

[2]. Grant to ACP to Helpers in Tech Pay Scale:

Department Informed the house that, a writ Petition is filed in Hon'ble High Court and decision will be taken accordingly.

President informed that it is already implemented for Helpers of Doordarshan Kendra Delhi and the Writ Petition is filed on behalf of Union of India without even consulting Union of India.

CEO instructed to look into the matter that how it happened.

[4]. Merger of EA and SEA and Exam for promotion of SEA to AE:

President informed the house that the examination is not conducted since last 7 years for want of merger of EA and SEA as per DoEXP OM dated 13.11.2009 and around 500 posts are laying vacant.

CEO instructed to look into the matter, expedite the Merger and to explore the possibility of conducting the examination.

[5]. Grant of Scale of Rs. 6500-10500 to Tech and Sr.Tech working in scale of Rs. 5000-8000 and 5500-9000 at par with Head clerks etc :

Department Informed that, it was demanded at par with Head clerks and that order is not implemented and the demand will be considered as per decision on the order about Head clerks.

### [6]. Cadre Review Exercise:

It was informed that Report received from Cadre Review Committee and it will be placed in Prasar Bharati in due course.

#### [7]. GPF Related Problems:

The problem discussed in the meeting. It is informed that out of 10 PAOs 8 are already computerized. CEO instructed to computerize remaining PAOs and to look into possibility of a single GPF number across the Country.

#### [8]. Election duty by Staff of AIR and DD:

It was informed that the issue is being taken up with Election Commission for exemption of staff and vehicles of AIR & DD.

#### [9]. Construction of an Auditorium in AIR and DD:

DG (AIR) informed that the decision is in Finalization Stage to construct an Auditorium in a Portion of Akashawani where way back Doordarshan Kendra was situated.

#### [10]. Additional Points:

President raised the issue of issuance of Calendar for DPC as it was being issued earlier. Member (P) said that including this one the issue of promotion is also important.

This is just the details of discussions. Minutes of the Meeting is awaited. From ARTEE side, President attended the meeting, since Addl.G.S./VP (TV) and other office bearers were busy in Court hearing of ACP PATNA in CAT Delhi.
