

Disciplinary Action Against Sh. Paritosh Kaushik EA

An unpleasant decision, but we are Compelled

Members are being regularly informed about the Anti Association Activities by Sh. Paritosh Kaushik to jeopardize this Association.

As we were aware, Sh. Paritosh Kaushik was refusing to release funds even for the essential Association activities, which are statutory and necessary for the existence of this Association. He was refusing to release funds for welfare related issues like ACP Patna etc.

ARTEE Central Office had appealed and requested Sh. Paritosh Kaushik to release funds several times, but he refused.

Ultimately an unpleasant decision of suspending Sh. Paritosh Kaushik, from the post of Treasurer was taken and a charge sheet dated 18.03.2016, mentioning charges of his Anti Association Activities with all the documents were issued to him. He was asked to submit his reply within one month.

Even after that Sh. Paritosh Kaushik continued Anti Association Activities like freezing the Association accounts etc. Later a supplementary charge sheet was issued on 04.04.2016 and Sh. Paritosh Kaushik was again asked to submit the reply of these charges.

In order to give him give him free and fair opportunity to explain his position, in the interest of justice this time was extended on 28.04.16 for another fifteen days, but till date even after passing two and half months, this Association has not received any reply whatsoever from Sh. Paritosh Kaushik.

Contrary to that Sh. Paritosh Kaushik has again filed a complaint in Banks again to freeze the Accounts of the Association which are defreezed with the efforts of the Central Office.

Despite repeated reminders Sh. Paritosh Kaushik has not returned the Assets of this Association like Fixed Deposits, Pan Card, Bills/Vouchers and other relevant documents which are in his illegal possession.

In addition to all these, Sh. Paritosh Kaushik has lodged complaint in the O/o Dy. C.P. New Delhi, against ARTEE Central Office bearers with the sole intention to harm this Association.

Central Executive in its Meeting held on 10.06.2016, discussed the issue and since no reply was received from Sh. Paritosh Kaushik and since Sh. Paritosh Kaushik is still involved in Anti Association Activities, **the House unanimously decided that Central Office is not left with any option except taking disciplinary action against Sh. Paritosh Kaushik.**

Henceforth the House unanimously decided to expel Sh. Paritosh Kaushik from the Membership of this Association.

This expulsion letter has been served to him as per decision of Central Executive Meeting dated 10.06.16.

Sh. Paritosh Kaushik is once again requested to return the Assets of this Association without any further delay failing which suitable action as per law of the land will be initiated against him.

All concerned officers are being informed accordingly.
