

Clarification About Deduction of RSA Subscriptions

It is understood that Some Engineering Employees, who left ARTEE are trying to spread misinformation about deduction of RSA Subscriptions and CCS (RSA) Rules.

They think that whatever they presume is always correct and they have the right to interpret Rules and Guidelines as per their own whims and fancies. They are not at all bothered about welfare of Employees in AIR and DD. Now they are trying their best to wrongly interpret RSA Rules and guidelines about RSA Subscriptions.

(2). There needs to be a clear cut directive to be issued by DG(AIR) or DG (DD) on the instructions of Prasar Bharati and Hon'ble Ministry of Information and Broadcasting for deducting or for not deducting RSA Subscription for any Association.

(3). Without the written request of any employee, no change in RSA Subscription can be done by the DDO. If there is no change in RSA subscription by the employee, then the Annual RSA subscription for the year 2017-18 should be deducted from the salary of April itself. If any employees alter/change his Authorization, then the change is to be submitted in the Month of April and it will be effective from the Month of July of that financial Year.

(4). There are many departments where Re Verification of Membership has not taken place since decades and till it is not done the existing Recognition is continued in the interest of Employees for redressal of their grievances.

Again our Question

Why they did not propagated all those interpretations when they were in ARTEE and why they are propagating it now?

Their attitude is that if I am on top posts everything is good and when I am not in top post, whatever others doing is not correct and whatever I am saying is correct.
