

Compilation of Clarifications about RSA Subscriptions

Some people who left ARTEE are trying to spread misinformation about RSA Subscriptions and CCS (RSA) Rules.

Now let me tell some basic facts about deduction of RSA Subscription.

(1). RSA Subscription cannot be deducted for any Association just by submitting the Forms to DDO. Similarly RSA Subscription for any Association cannot be stopped without any order.

(2). There has to be a clear cut directive to be issued by DG(AIR) or DG(DD) on the instructions of Prasar Bharati and Hon'ble MIB for deducting or not deducting RSA Subscription for any Association.

(3). without the written request of any employee, no change in RSA Subscription can be done by the DDO. If any employees alter/change his Authorization, then the change is to be submitted in the Month of April and it will be effective from the Month of July of that financial Year.

OFFICE MEMORANDUM.

Subject : Procedure for verification of membership of Associations for the purpose of recognition under the Central Civil Services (Recognition of Service Associations) Rules, 1993.

2.3 Consent for deduction of annual subscription shall remain valid till altered or withdrawn. The revised option for deduction, if any, can be exercised only in the month of April each year to be effective from July of that year.

Clause 2.3 clearly says that Consent will remain valid till altered or withdrawn. So Members who change the option for them only the subscription will effective from July.

Hence all Unit Secretaries and CWC Members are requested to make sure that RSA Subscription is deducted in the months of April and as early as possible. If any DDO is not doing this ask them to show the order from AIR/DD Directorate.
