Subject : Request for preparing proposal and sending it to Hon'ble Ministry of I & B / Deptt. of Expenditure for grant to benefit of 7th CPC for Prasar Bharati Employees.

Respected Sir,

With warm regards, this is to remind you that Employee appointed after 5th Oct 2007 are yet to get the benefit of 7th Pay Commission. Pl. refer to this Associations letter as mentioned above. When we pursued the issue, Prasar Bharati issued a letter on 26/09/2016 and informed that issue will be taken up after issuance of guidelines by Deptt. of Expenditure.

It is pertinent to mention that Deptt. of Expenditure under Ministry of Finance has issued detailed guidelines for the same. As per clause 3 which is reproduced below :

3. The revised pay scales contained in Parts B & Part C of the Schedule of the CCS(RP) Rules, 2016, shall not be automatically applicable to the employees of Autonomous Organizations. The concerned Administrative Ministry shall consider such cases keeping in view whether these pay scales are justified for the category of staff of Autonomous Organizations based on functional considerations, recruitment qualifications, as well as the applicable pre-revised pay scales. Based on such an examination by the concerned Administrative Ministry, appropriate proposals, if justified, would be submitted to the Ministry of Finance, Department of Expenditure, through their Integrated Finance.

As per this clause Prasar Bharati has to prepare a proposal with full financial implications and this proposal is to be sent to Deptt. of Expenditure through Administrative Ministry i.e. Hon'ble Ministry of I & B.

As per clause 5 (iii) which is reproduced below

- (iii) In respect of Autonomous organisations set up under a specific Act of Parliament, not generating adequate internal resources to meet the additional financial impact, the extent of Government support may be more than 70% of the additional impact, provided in the opinion of the concerned Financial Adviser the nature of functions and the fund position of the organisations so warrant.

Since we are formed by specific act of Parliament and dependent on Govt. Grant. PB falls in this category and grant to us for this may be more than 70%.

In the list of Autonomous Corporations, Prasar Bharati is mentioned at Sr. No. 269, (Copy enclosed as Annexure IV).

Sir, in the light of above mentioned facts, now the onus is on Prasar Bharati to prepare the proposal. We request you to expedite the work so that these deprived employees can get justice.


Respected Sir,
