With warm regards, we want to convey our thanks for your order to grant pre revised scale of Rs. 4500-7000 to Tech working in 4000-7000 and joined after 25/2/1999 and before 05/10/2007 through order no. 14/02/2015-S-IV(A)/J 313. dated 16/5/17. (copy of Order enclosed as Annexure – I).

Pl. Note that prior to this order DG(AIR) the granted the pre revised scale to Technicians working in the Pre revised scale of Rs. 4500-7000 Order .through Order 8/20/2015-S-IV(A) dated 12/05/2017 w.e.f 01/01/1996. (copy of order enclosed as Annexure – II). We want to draw your kind Attention towards the para 2 of this order which is reproduced below :

2. As per approval of Ministry of I & B, it has also been decided to extend the pay scale of 5000-8000/- to all other similarly placed eligible Technicians who have not gone to any court or have recently filed any court cases.

It is pertinent to mention that all Technicians granted scale of Rs. 4500-7000 as per DG(AIR) Order No. 14/02/2015-S-IV(A)/J 313. dated 16/5/17 are perfectly similar to all Technicians who have been granted scale of 5000-8000 as per order dated 12/5/2017.

So we request your high office to grant pre revised scale of Rs. 5000-8000 to Technicians as per Order 8/20/2014-S-1V(A) dated 12/5/17 since they are similarly placed to the incumbents Technicians who are of beneficiaries of 12/5/17 Order after the granted scale of Rs. 4500-7000 as per DG(AIR) Order No. 14/02/2015-S-IV(A)/J//313 dated 16/5/17.


We humbly request your kind intervention to avoid further litigations.
