Subject : **Request to issue corrigendum about DG(AIR) order 8/20/2015-SIV dated 12.05.17 about pay parity with Lighting Assistants and DG(AIR) Order 14/02/2015- S IV(A)-313 dated 16.05.2017 for grant of Scale of Rs. 4500-7000 to the Technicians joined after 25/2/1999.**

Respected Sir,

With warm regards we convey our sincere thanks for settling the above mentioned issues. After the issuance of above mentioned orders some genuine concerns are raised by various offices and these confusions are hampering the implementation of the orders. We hereby mention some of the concerns and confusions about the issues.

[1]. Fixation of Sr. Technicians :

The order issued by DG(AIR) order dated 11/03/2014 in compliance of SLP(C) 33048 was having a mention of Tech and Sr. Tech both. Sr.Tech. all around the country had not faced any problem in fixation.

The order issued by DG(AIR) on 12/05/17 for grant of pre revised scale of 5000-8000 w.e.f. 01/01/1996 has no mention about Sr.Tech even when Sr.Tech were Applicants in Individual Cases as well as in Association's cases as Member. This has created a state of confusion and Fixation work for Sr.Technicians is not being done in many offices. These offices are sending queries also to DG(AIR).

[2]. Grant of MACP :

Grant of MACP to beneficiaries to Tech vs LA and Orders dated 12/05/2017 and Order 16/05/2017 for Grant of Rs. 4500-7000 to Technicians of Rs. 4000-6000 scale is not clear. It is pertinent to mention that all these Employees have completed service more then 10 years and entitled for MACP Benefits.

We request you to issue corrigendum at the earliest to clear above mentioned confusions so that implementation of these order may progress smoothly. An urgent intervention is requested.

Subject:- Implementation of the order of Hon'ble Supreme Court dated 10.01.2013 in SLP (C) No.33048 filed by the UOI Vs. AIR and Doordarshan Technical Employees Association-reg.

In accordance with the approval of Ministry of Finance conveyed by the Ministry of I&B vide their letter No. 515/09/2011-BA (E) dated 18.2.2014 & 07.03.2014 to the implementation of the order of Hon'ble Supreme Court dated 10.01.2013 in SLP (C) No.33048 filed by the UOI Vs. AIR and Doordarshan Technical Employees Association upholding the Madras High Court's Order dated 24.11.2010 in W.P. No. 27155/2009 to grant the benefit of notional pay fixation to the post of Technician and Sr. Technician enhancing their pay scale at par with Lighting Assistants Grade-I & II without any award of arrears, the pay scale for the post of Technician and Senior Technician is notionally enhanced as under:-

1.	01.07.1983 to 31.12.1985	Rs. 425-700
2.	01.01.1986 to 31.12.1995	Rs. 1400-2300

2. This approval is subject to the condition that there will be no financial outgo on payment of arrears.
3. All Zonal Heads of All India Radio & Doordarshan are requested to re-fix the pay in respect of the concerned officials notionally w.e.f. 1.7.1983 upto the date of issue of this order without any arrear.
