[4]. No SEA is promoted since last 7 yrs due to pendency of EA/SEA Merger.

- [5]. No Scope for promotions Diploma AEs since last 30 yrs even after recommendations of so many committees.
- [6]. All of these cadres are under the threat of Downgradation, Refixation and Recovery due to treating 25/2/99 scales as Upgradation while granting MACP.

[7]. ACP is not granted to all of these cadres.

[8]. Many Other issues.

We hereby humbly remind you about our request to spare some of your valuable time for a meeting with the representatives of our Association (ARTEE) as early as possible to discuss. We also demand that one Open House should be called for the cades of Helper to AEs as early as possible.
