Subject : Delay in sending reply to Prasar Bharati about merge of Tech with Sr. Tech in the light of DG(AIR) Order dated 14/03/2014 and dated 12/5/17 granting re revised Pay Scale of Rs. 5000-8000 in Pay Parity with Lighting Assistants.

With warm regards this is in continuation of our previous letters on the subject stated above. The Tech and Sr.Tech Cades are feeling disappointed due to inordinate delay in replying the query raised by Prasar Bharati on the issue of merger of Tech with Sr. Tech in the light of DG(AIR) Order dated 14/03/2014 and dated 12/5/17 granting pre-revised scale of Rs. 5000-8000 in Pay Parity with Lighting Assistants.

## Issue of Merger of Tech and Sr. Tech

As per DG(AIR) orders 8/8/2006-SIV(A)/Part-I/107 Dated 11<sup>th</sup> March 2014, DG(AIR) order 8/20/2015-S-IV(A) Dated 12/05/2017, Tech vs Lighting Assistants, DG(AIR) order 14/02/2015-S-IV(A)/313 dated 16/05/2017 and DG(AIR) order 8/20/2015-S-IV(A)/778 dated 18.12.2017 with the approval of nodal Ministries and Competent Authorities, all Tech and Sr. Tech joined upto 5<sup>th</sup> Oct 2007 are placed in pre revised scale of Rs. 5000-8000 i.e. GP 4200.

It is pertinent to mention that DG(AIR) has already approved merger of Tech/Sr.Tech in 5000-8000 scale i.e. Grade pay 4200 and sent a proposal way back in 2016. Prasar Bharati sought some more information but the same is pending in DG(AIR) since more then six months.

Henceforth we request your high office to send the reply of the query to Prasar Bharati so that issue may progress further.
