Subject:- **Request to allow eligible EAs to appear Limited Departmental competitive Examination for promotion of SEA to AE as per notification no. NABM-Deptt. Exam/SEA-AE/2017 dated 17/11/2017. Interim Directions in OA 332/0049/2018 dated 12-03-2018 at Hon. CAT Lucknow Bench Regarding.**

Reference : Our previous Letter ARTEE/P/178/12/2017 dated 12/12/2017. (copy enclosed).

Respected Sir,

With reference to above subject your kind attention is invited that as per notification no. NABM-Deptt. Exam/SEA-AE/2017 dated 17/11/2017 LDCE for the post of AE is going to be conducted on 17th & 18th March 2018. As per this order only SEA's are eligible with 8 years of total service to appear in the exam. It is important to mention that DG AIR and Prasar Bharati have already approved the merger of SEA and EA and final proposal already approved by Prasar Bharti board and sent to ministry.

Some Engineering Assistants approached the Lucknow Bench of CAT and they are provisionally allowed to appear in the LDCE for AE according to the order dated 12-03-2018 by the Hon'ble CAT. **There are several judgments of the Apex court that similarly situated persons are to be treated in same manner.** It is requested that all similarly placed EA's to the applicants in OA 332/0049/2018 at Hon. CAT Lucknow Bench must be allowed to appear in LDCE for the post of AE to be held on 17&18 March 2018 as per notification no. NABM-Deptt. Exam/SEA-AE/2017 dated 17/11/2017.

Madam, there is around 2500+ Engineering Assistants in this department who are working since their joining without any promotion whatsoever. The implementation cell Department of expenditure through OM dated 13.11.009

considered and it has now been decided that the post which were in the pre revised scale of Rs.6500-10500 as on 01.01.2006 and which were granted the normal replacement pay structure of grade pay of Rs.4200 in the pay band PB-2 will be granted of Rs.4600 in the pay band PB-2 corresponding to the pre revised scale of Rs.7450-11500 wef 01.01.2006.. Further, in terms of the aforementioned provisions of CCS (RP) Rules, 2008 in case a post already existed in the pre revised scale of Rs.7450-11500, the post being upgraded from the scale of Rs.6500-10500 should be merged with the post in the scale of Rs.7450-11500.

Henceforth, in the light of CAT Lucknow order (copy enclosed), we request you to kindly allow all eligible EAs to appear in the Examination for the post of AEs. Your kind intervention is required urgently in this regard.
