Subject: Request to issue Clarification about consequential benefits in grant of Technicians joined between 25/2/99 to 05/10/2007, earlier working in pre revised scale of 4000-7000, granted scale of Rs. 4500-7000 and now granted scale of 5000-8000.

Respected Sir,

With warm regards, we want to bring in your kind notice about following sequence of events on the issue.

- [1]. As per DG(AIR) order 8/20/2015-S-IV(A) Dated 12/05/2017 the Technicians working in the pre revised scale of Rs 4500-7000 and joined upto 05/10/2007 were granted pre revised scale Rs. 5000-8000 Notionally upto May 2015 and with Arrears for later period. In this letter it was clearly mentioned that this benefit will be available to all who are similarly placed. (copy enclosed As Annexure I)
- [2]. As per DG(AIR) order 14/02/2015-S-IV(A)/313 dated 16/05/2017 the Technicians working in pre revised scale of Rs. 4000-6000 joined between 26/2/1999 to 05/10/2007 granted scale of 4500-7000 with consequential benefits from Date of Joining. (Copy enclosed as Annexure II).
- [3]. As per to avoid further litigation, DG(AIR) order 8/20/2015-S-IV(A)/778 dated 18.12.2017 these Technicians who granted 4500-7000 as explained in clause [2] were further granted scale of Rs. 5000-8000 Notionally since they became similarly placed with Technicians explained in clause [1].

We have received complaints from many of our Members that in stations Admin people are now refusing to pay Arrears to Technicians in scale Rs. 4500-7000 as per order dated 16/5/17 from their date of joining and now fixing them in 5000-8000 scale Notionally which is violation of DG(AIR) Orders, Court Verdicts. It is pertinent to mention that all above orders are issued with the Approval of competent Authorities and Deptt of Expenditure gave approval of Arrears around Rs. 35 Crores. Anyone at stations has no authority to deny these beneficiaries from Arrears.

We humbly request you to kindly issue a clarification that first Tech/Helpers working in 4000-6000 and joined between 25/2/1999 to 05/10/2007 will be granted scale of Rs. 4500-7000 from Date of Joining with all consequential benefits so from Date of joining as per DG(AIR) dated 16/5/17. After this when they become Similarly placed to the incumbents of 12/5/17 order they will be granted 5000-8000 Notionally (Arrears from May 2015).

An urgent intervention is requested.
