With warm regards, we hereby request you to expedite EA and SEA Merger in 4600 GP (pending since 2010) in the light of Order by Hon'ble High Court in hearing Writ 8712/18 file by HMIB on 20/8/18 to challenge Verdict in OA 282/2018 by Sh. Vijay Haroor and Ors., decision of Prasar Bharati 139<sup>th</sup> PB Board Meeting and Verdict in OA 2940/10 by Praveen Kr and Ors.

Order by Hon'ble High Court in WP(C) 8712/2018 by Hon'ble Ministry of Information & B'casting:

This is to inform your high office that Hon'ble MIB has challenged the verdict of CAT PB Delhi in OA 282/18 to do the compliance by merging EA and SEA in Grade Pay 4600 in 90 days. Hon'ble High Court while refusing to admit the Writ has asked the Applicants to file an Affidavit by an office not less then the level of Joint Secretary in a period of four weeks with clearly stating the reasons for non compliance in last seven years. (Copy of the High Court Order is enclosed as Annexure – I).

We have been demanding to merge these twin posts of EA and SEA as per DoEXP OM Dated 13/11/2009 w.e.f. from 01/01/2006. This OM is in continuation of recommendations of 6<sup>th</sup> Pay commission. It is a matter of concern that an Order released as per recommendations of 6<sup>th</sup> CPC is pending to be implemented even when 7<sup>th</sup> CPC is implemented.

For your reference we once again request your high office to do merge the twin cadres of EA and SEA in Grade Pay 4600 w.e.f. 01/01/2006 in compliance of DoEXP OM dated 13/11/2009 (enclosed as Annexure-II), verdict of OA 2940/10 (enclosed as Annexure-III), OA 282/18 (enclosed as Annexure-IV) and Prasar Bharati Board decision taken in 139<sup>th</sup> Board Meeting (enclosed as Annexure-V).

An early action is requested.
