2. The representations from applicant Associations have been received that DDOs of Doordarshan Offices are not deducting membership fee/annual subscription from employees posted in Doordarshan Kendras who wish to affiliate themselves to any of the applicant service Associations.

It is therefore, requested that suitable directions may be issued from DG:DDn. to all HoO/DDO of subordinate offices of Doordarshan for deduction of membership fee/annual subscription as the case may be, for employees who wish to affiliate themselves to any of the applicant service Association after obtaining authorization from the desirous employees for subscription and send a consolidated list category wise along with copy of authorization to this Directorate latest by 31st March, 2019. The proforma authorization form is attached in **Annexure-I** with this letter.

Also President, Federation of Doordarshan Core Professionals, Doordarshan Kendra, Thiruvananthpuram vide mail dated 05.01.2019 (copy enclosed) has informed that Association has submitted their entire documents to DG:Doordarshan on 21.11.2017. But it is to inform that the same has not yet been received in this Directorate till date. Hence, suitable action in this regard may also be taken.


