Subject: Suggestion to install Solar Power plants in the land of Short Wave Transmitters throughout the country

With warm regards, as Prasar Bharati is going to close some HPTs and SPTs (Shortwave Transmitters) throughout the country due to various reasons. However we do not agree with this and are protesting on the issue since this will cause mass displacement of Staff.

Based on suggestions received from our Members, we request you to install solar power generation plants in these lands. This way we can convert out loss making stations into profit centers as the electricity generated may be sold to state electricity board and other civic authorities.

- 4- Area is fully fence with boundary wall having 2 Nos. of bore wells and underground sump water tank of 1 lac liters capacity.
- 5- Having 1 No. 240 meters and 2 Nos. 60 meters high masts.

- 6- Open area can be used for generating about 4 MW of solar Electricity Power without disturbing & cutting jungle within premises. If arrangement is made with MSEB the power bills of all the establishments of Prasar Bharati of Nagpur distict can be reduced to zero in lieu of Solar Power generation at SPT AIR (Butibori) premises.
- 7- Transmitting station for AIR Nagpur 300 KW at kamptee can be shifted to Butibori or any other service can be taken on exiting transmitter of SPT. So that Prime location land can be saved for development, otherwise this land will be taken back by state government.
- 8. The money required for Installing Solar Power plants may be met by auctioning scrap of these stations.

The similar lands are available in all transmitting establishments like Kingsway, Nangli, Mall Road, Todapur, Khampur (Delhi), Malad etc (Mumbai), Awadi Chennai, Yelahanka, (Bangalore), Chinsurah, Aamtalla (West Bengal) and so many places in whole country.

We request you to take immediate necessary steps like sending a comprehensive proposal to Hon'ble Ministry I & B.

An urgent action on the subject is requested.
