Subject : Delay in releasing lists of all other 4 zones except North and Notification of LDCE for SEA to AE Promotions.

Respected Sir,

With regards, this is in continuation of this Association's previous letters through which we expressed our concern about the un similarity in EA to SEA Promotions in all zones. To avoid any discrimination among SEAs of zones, we suggested to release the promotion lists of all zones on a single day but our demand is not accepted. During discussions with ADG(A) and DDG(A) it was agreed upon eradicate this anomaly through issuing necessary instructions. Meanwhile O/o ADE(E), North Zone has issued a promotion list of 283 EAs for promotion to SEA. We welcome the step but once again want reiterate that it has pushed the EAs of all other four zones in disadvantageous position as far as inter se Seniority and other issues like eligibility for further promotions are concerned.

We once again want to draw your attention for following of the issues :

[1]. Eligibility for SEA to AE Promotions :

As per RR the eligibility criteria for SEA to AE Promotions is that an EA should be SEA as on 1st Jan of the year in which the LDCE Examination is being conducted. Now since EA to SEA promotions are delayed, none of these promoted SEA will fulfill this criteria. We submit our views and options as below :

As list of other zones except North is not released, the examination for SEA to AE promotions may please be conducted only after release of list by other zones. This is must to treat all SEAs on equitable basis to give them free and fair chance in promotion..

[2]. Fixing the responsibility in delaying the promotions in Other Zones :

We also demand that Zonal ADG(E) of all other Zones may be held responsible for their lethargic and beurocratic approach full of Red Tapism in delaying, conducting DPC and sending those for Vigilance clearances.

We seek and request your urgent intervention on the issue by issuing necessary instructions to avoid any further discrimination with EAs of any other zone.
