3. To pay all his dues as per rule by Dept quickly.

4. To force Dept to follow the norms & safety methods of INDIAN ELECTRICITY RULES strictly while working (on duty) uniformly at all the stations of DD & AIR in our Dept.

5. To "Abolish the system of One man shift for all stations" (which are still in practice).

6. As a responsible association we have demanded it many times before too & now also on priority.
