Subject : **Resentment against irrational postings on closure of LPTs in violation of Guidelines issued by Prasar Bharati for this purpose.**

Respected Sir,

With warm regards, through this letter we want to express our resentment about recent transfer lists released in East Zone to Re deploy the staff of closed LPTs. The list is in clear violation of Guide lines issued by Task Committee of Prasar Bhrati to adjust staff. The Non transferrable cadres even Tech and Helper are posted to far places despite possibilities of adjustment in nearby places. It seems transferring Authorities of East Zone wanted to take revenge from Staff by causing maximum disturbances even when Prasar Bharati has clearly instructed to adjust staff in nearest possible places. In these transfer list not only staff is troubled by a big financial expenditure is caused as the staff has to claim TA/DA when went on to transfer to remote places.

We have carefully studied and prepared a list of case where the staff Member could have been adjusted against the vacant post nearby but not given the posting.
