**Subject : Protest against illegal Recovery by PAO in DDK Lucknow by treating 25/2/99 scales as an upgradation while granting MACP in violation of court orders in contempt CP 371/2018 OA 2479/2015 by this Association.**

Respected Sir,

With regards, this is to bring in your kind notice that in Doordarshan, Kendra Lucknow has recently audited the service books of Engg. And Program officers who are the beneficiaries of 25/2/1999. To utmost surprise the PAO gave instructions to head of the station to recover huge amount in contravention of Court Orders. This Recovery is due to treating 25/2/99 scales as upgradation while granting MACP.

It is pertinent to mention that this Association had filed an OA 2479/2015 to challenge the impugned order 08/9/2014. Learned CAT on 13/7/2015, put stay and restricted Deptt from taking any adverse order on the order 08/9/2014 by Hon'ble MIB. (orde enclosed as Annexure-I). This order was till next date and on next date i.e. 27/7/15 the stay is converted in an Absolute Stay. (Order enclosed as Annexure - II).

Ld CAT allowed this OA on 01/12/2017 and clubbed with the WPC 2034/2017 by Madam Shyamali Biswas pending in Hon'ble HC Delhi.

DG(AIR) issued another impugned order 26/6/2018 and on 29/6/2018, this Association filed Contempt CP 371/2018 in above mentioned OA 2479/2015. A relief on 26/6/18 order was sought. Ld CAT instructed the Respondents **Not to issue any coercive order against Applicants.** (Copy of Order enclosed as Annexure - III). This direction is continue till today.

**It is worthy to mention that Principle Accounts Officer and DoPT are also Respondents in the OA 2479/2015 and the instructions of PAO are clearly coercive and being Respondent PAO has to be abide with the order in contempt CP 371/2018.**


From above mentioned sequence of events it is clear that PAO instructions are in violation of Court orders and needed to be stopped immediately.

Your urgent intervention is needed to maintain industrial peace.




